REPORT OF THE CORPORATE DIRECTOR OF PLACE

GRANT AID INNOVATION FUND 2015/16 (YOUTH)

Purpose of the Report

1. To seek approval for the award of grant aid to Voluntary and Community Sector Organisations through the Innovation Fund.

Information and Advice

- 2. At the meeting in March 2015 the Grant Aid Sub-Committee agreed that £50,000 per year from the £1.75 million grant aid budget be set aside for an "Innovation Fund". In the first year of the fund, members agreed that the theme in 2015/16 should be **Youth.**
- 3. The Innovation fund has been created to:
 - Facilitate new and innovative ways of working
 - Support projects requiring one-off investment Kick Start funding
- The first year of the innovation fund seeks to support Youth Projects which provide positive activities
 for young people between the ages of 10-19 (up to 25 years in respect of young people with
 disabilities).

Fund Application Process

- 5. The total fund for 2015/16 is £50,000; applications were sought for grants with a maximum value of £10,000. An open application round was launched on 19 June 2015 and closed on 31 August 2015.
- 6. The opportunity to apply for funding was widely promoted and included:- press releases, use of the County Councils website and social media channels, bulletins through infrastructure providers/Youth organisations and a briefing note for all County Councillors.
- 7. A total of 29 applications were received by the closing date with a combined value of £212,090 over 4 times the value of the available fund.
- 8. In addition to the key areas detailed at paragraph 3 above the application form had 10 sections which were used to assess the proposals, examples of areas considered included:
 - Innovation: whether the project will test new / creative approaches or solutions or is a kick-start new project
 - Sustainability: whether the project can be sustained after the funding ends
 - **Benefits:** the short term benefits that will occur during the life of the project; and the anticipated legacy, are they clear and substantial?

- Other funding & support: levels of other funding or support committed to the work, do the costings represent good value?
- **Deliverability:** that young people are involved in the design, delivery and management of the project; that the project objectives are achievable given the capacity and capability of the organisation and the available resources.
- 9. Members are asked to consider the recommendations listed in Appendix 1 of this report. A total of 13 applications are proposed for approval with a combined value of £50,000.
- 10. A number of the proposals not recommended for support were identified as having the potential to be supported through other funding streams. It is proposed that the Community & Voluntary Sector Team contact these organisations to provide detailed feedback and offer support where required. Members will be provided with an update on this work at a future meeting.

Other Options Considered

11. All the applications received have undergone assessment and moderation as agreed through the Corporate 3 Year Grant Aid Programme by officers.

Reason/s for Recommendation/s

12. The role of the Voluntary & Community Sector of Nottinghamshire play a vital role in the well-being of County residents and the grants awarded will deliver a range of innovative Youth projects across the County.

13. This report has been compiled after consideration of implications in respect of crime and disorder, finance, human resources, human rights, the NHS Constitution (Public Health only), the public sector equality duty, safeguarding of children and vulnerable adults, service users, sustainability and the environment and ways of working and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

REPORT OF THE CORPORATE DIRECTOR OF PLACE **UPDATE ON CORPORATE GRANT AID PROGRAMME**

Purpose of the Report

- 1. The purpose of this report is as follows:
 - a) To update members of the Grant Aid Sub Committee on key activities being supported through the Community & Voluntary Sector Team
 - b) To seek approval to provide Grant Aid funding to Rushcliffe CVS for the delivery of the Voluntary Transport Scheme in the Gedling area
 - c) To seek approval for a refreshed approach to the Community Commemoration Fund
 - d) To seek approval for a refreshed Arts Grant Aid application round

Information and Advice

- 2. As a part of managing the delivery of the corporate grant aid programme, the Community and Voluntary Sector Team work in partnership with voluntary and community groups to ensure that Nottinghamshire has strong communities that are safe and thriving. The reality of the challenges faced means that the Council of the future will be different in the way it is shaped, organised and how services are delivered. The Council is committed to working in partnership with local communities, voluntary groups and volunteers to provide services.
- 3. Work being undertaken by the team which seeks to support ways to develop and strengthen engagement with communities, moving towards a changed landscape of local services with new and innovative models being implemented. The contribution made to improving public services and wellbeing in Nottinghamshire by communities and the voluntary sector is recognised and supported through both the Council's extensive grant aid programme and direct hands-on support from Community Officers.
- 4. A welcome addition to the team was the recent appointment of an apprentice through the County Council's apprentice programme. The position we have appointed to is a Community Empowerment Assistant and will be based at our office in Mansfield Woodhouse, the wider team have really embraced welcomed the opportunity to help develop a young person.
- 5. All 117 organisations, who have been approved 3 year grant aid funding 2015 have grant aid agreements in place and work is ongoing focusing on building relationships with groups to support future sustainability and success. Of those organisations that were not recommended for funding, over 30 groups have responded to the offer of support and diagnostic visits have been either conducted or arranged by members of the team.
- 6. This support and relationship building is in recognition of the change in recent years of how economic circumstances have drastically changed how organisations are funded with the result that only well organised third sector groups can thrive and provide a valuable contribution to the local community.

Only by being robustly established and equipped to respond to new challenges can the wealth of voluntary sector organisations across the County maximise the positive impact that they have on local communities.

- 7. The work of the Community and Voluntary Sector Team underpins the Council's commitment to building on its reputation of working in partnership with the community and voluntary sector to help build local capacity. The range of activities which members and officers are involved in, alongside the provision of grant aid funding seeks to help to drive programmes with communities to deliver local solutions and move towards providing services in a different way. Building confident and stronger communities is especially important within the current climate and the Team has been working with different communities to help support local activities which bring individuals together to celebrate the uniqueness of localities. This has included:
 - a) Support to Eton Avenue Growers Community Allotment initiative which encourage local people with learning difficulties and mental health challenges to engage in growing their own produce and selling them to local people and businesses. The initiative has been faced with dwindling volunteer numbers and help with arranging an open day and seed exchange alongside seeking funding for the purchase and installation of a dried compost toilet it is hoped more volunteers will be attracted.
 - b) Working with groups which are operating in areas of disadvantage or that are facing high levels of exclusion or disadvantage, for example, providing support to Kingsway Community Hall to develop a 5 year Reaching Communities Lottery application worth £374,000 over 3 years to enhance services to older people and develop the youth club. Stage 1 of the application process has been successful.
 - c) Working with groups who are going through a period of transition or change within their organisation and are motivated to work with others and share their own experiences and learning, for example, developing a relationship with Vision School Mansfield to develop opportunities for students to engage in community projects with voluntary organisations.
 - d) Undertaking community development work which has a positive and lasting impact on the local community, for example, supporting the development and build of Rainworth Skate and Play Park which has reduced vandalism and inappropriate behaviour in the area, alongside providing leisure and physical activity opportunities for young people in the community.
 - e) Capacity building in communities to support and equip people with the skills and knowledge to help them contribute to their changing communities, for example, work is being developed to establish a 12 month pilot scheme of support for people in the more isolated rural areas of Bassetlaw. The pilot will offer a range of health and wellbeing services within the local community, using church resources, in partnership with the district council, NCC and the CCG and other appropriate agencies such as Advice Bassetlaw. A rural community hub will be created, giving people at risk of, or experiencing social and rural isolation, access to a social network and a variety of services.
 - f) The recruitment and appointment of a Community Empowerment Apprentice to support the team, bringing a young adult's perspective to the challenges ahead alongside learning skills in community development.

Nottinghamshire's State Of Sector Survey

8. The Centre for Regional Economic & Social Research from Sheffield Hallam University has conducted an independent survey of the Voluntary & Community Sector (VCS) of Nottinghamshire. The survey was commissioned by Nottinghamshire County Council and co-designed with representatives of Nottinghamshire's VCS.

- 9. The survey findings will provide a valuable insight into the contribution the VCS play in Nottinghamshire and help to develop the Council's approach to community empowerment and resilience as approved by Policy Committee in July 2015.
- 10. Two events have been planned to disseminate the results of the research 20 October 2015 at the Everyday Champions Centre in Newark and 23 October at County Hall. All Nottinghamshire County Councillors have been invited to attend one of the events and it would be particularly welcomed if members of this committee could attend an event. Delegates will be able to learn about the:
 - a) Anatomy of the Sector What does the Sector do in Nottinghamshire?
 - b) Financial Position in Nottinghamshire
 - c) VCS Workforce Paid & Volunteers and the contribution this makes to the County
 - d) Relationships with the Public Sector & with Commercial Businesses
 - e) Relationships with other Voluntary Sector Groups including those that offer support.
- 11. Most importantly there will be the opportunity to explore the opportunities and challenges identified by the survey and develop plans for more collaborative working for the benefit of Nottinghamshire's communities.

Gedling CVS

- 12. Members may be aware that Gedling CVS have decided to close after almost 50 years of operation in the Borough, the final day of operation will be 16 October 2015. The Community & Voluntary Sector Team have met several times with trustees and senior staff over the past 2 months to offer support and guidance through this difficult time.
- 13. Over recent years the CVS have delivered a range of contracts and received grants from the Borough and County Council, they also delivered a number of health related projects on behalf of the Clinical Commissioning Group and its predecessors. These opportunities have diminished over recent years.
- 14. At the point of closure there will be one outstanding grant and that relates to the Voluntary Transport Scheme Volunteer car drivers for vulnerable & isolated individuals. This scheme involves the coordination of a team of volunteer car drivers and officers are confident that through existing providers that this scheme will be able to continue. It is recommended that RVCS is funded to deliver this service on an interim basis and further work is untaken with providers to establish how the service will continued to be delivered from July 2016 to June 2018
- 15. The Community & Voluntary Sector Team are exploring ways of securing support for other areas of work, which includes: like volunteer recruitment and group development, an update on progress will be provided at the next Grant Aid Sub Committee.

Provision Of An On-Line Funding Portal

- 16. At the Grant Aid Committee meeting in January 2015 members were able to see a practical demonstration of an on-line funding portal which has been developed by a company called idox. The portal provides comprehensive coverage of all available funding opportunities, including European Union, national Government programmes, regional schemes and local initiatives, and is kept fully up to date.
- 17. Information is continually updated and checked for accuracy by a team of specialist researchers. In excess of 20 full time staff are working on the funding content at all times. The portal will be customised with County Council branding and is accessed by a link from our website.

- 18. It also includes a number of proactive features that offer users additional value. Automatic email alerts can be set up so they are first to know when relevant new or updated funds are added, as well as signing up to weekly newsletters packed with the latest funding announcements.
- 19. Users access the funding portal via an email-based registration process, giving the council really useful intelligence on use of the service. Monthly statistical breakdowns are also provided to help evaluate the portal's impact and help demonstrate its value for money. All content is subject to a strict editorial process that ensures the information provided is consistent, accurate and relevant.
- 20. The portal provides a customised internet based opportunity for the Voluntary & Community Sector to access information on funding opportunities. Members approved the development of the portal for Nottinghamshire subject to Community and Voluntary Sector Team and the Digital Inclusion Team ensuring that any product purchased is designed and implemented in line with the Councils Digital First approach.
- 21. In the spirit of collaboration and joint working it is recommended that the provision of this service is jointly delivered and promoted by the County Council and the Community & Voluntary Sector. The proposal is that the portal is hosted by Nottinghamshire Together with links from the County Council website making it clear that the service is funded by the County Council.

Community Commemoration Fund

- 22. The latest round of Commemoration Fund applications were assessed on 21 July and will be supporting 8 projects with awards totalling £2,400. These are contained in the appendix to this report.
- 23. This fund has successfully attracted a varied range of interest, particularly in 2014, the centenary year of the outbreak of war. As members will be aware this fund is committed to allocate £10,000 per year till 2018.
- 24. It is recommended that an element of this fund is used to maximise the wealth of World War 1 documents held in Archives which could be developed into education packs for groups of young people to use to broaden their knowledge and understanding of the importance and impact of the First World War. Funding would support the development of information packs, both physical and digital making them as interactive as possible. Themes to be considered include:
 - a) Captain Albert Ball Local hero, and ace pilot, lots of documents on his life and letters.
 - b) Sherwood Foresters Local regiment, links to museum at Thorsby, Mercians regiment now at Chilwell Barracks.
 - c) Telegrams and communications letters from the trenches and from home
 - d) Children in the War Roman Pegg and Billy Richards diaries and school log books on activities during the period.
- 25. The broad brush themes are around local people and local history in WW1, with a focus on the local angle compared to resources available through National Archives. These themes fit with curriculum areas of History and Literacy, but could also include communication, visual literacy, arts activities, food of the war and drama ideas especially using transcripts of oral history that are deposited in Archives.

26. Packs could include:

- Teacher and leader notes,
- Photos, films.
- Actors reading transcripts and activities for the class room.

Visits to Archives would be part of the offer to handle original objects visit the building and have a practical activity having used the packs in school. Options to write the materials to be for leaders of any groups not just schools e.g. U3A history groups etc.

27. It is recommended that the CCF grant is allocated to supporting projects as outlined above alongside the continued support to local projects.

Arts Grants

- 28. The County Council is committed to supporting Nottinghamshire Citizens to benefit from arts projects across the county. Through the Nottinghamshire Arts Fund, grants are awarded to support arts projects which aim to help get more people to participate in the arts in Nottinghamshire.
- 29. In previous years the Arts Grant Fund has been open to applications bi-annually, it is recommended that going forward that applications are invited to cover 2016 18 which will bring the fund in line with the overall 3 year grant aid programme.
- 30. Opening in January 2016 applications will be invited from individual artists, members of the community, arts organisations as well as community and voluntary groups for projects which require funding up to £5000 per year for 2016 18. These should:
 - a) Be focussed on developing community engagement and participation in the arts
 - b) Have a minimum 10% funding from other sources as money or as in kind support that can be quantified.
 - c) Take place within the administrative boundaries of Nottinghamshire (this excludes the city of Nottingham)
 - d) Involve one or more professional artists (by professional artist this means a person who earns more than 50% of their income from there practice)
 - e) Benefit the citizens of Nottinghamshire.

The term "arts project" is flexible. It may be a single event, a series of workshops an exhibition with community links, a programme of music an artist residency programme or a festival of arts.

REPORT OF THE CORPORATE DIRECTOR PLACE SUMMER PLAY SCHEME GRANT AID PROGRAMME 2015

Purpose of the Report

- 1. The purpose of this report is twofold:
 - To provide Members with an update on Summer Play Scheme Grant Aid allocations for 2015 and to:
 - Seek Members approval to new arrangements for the allocation and approval of the summer play scheme fund for 2016 to 2018.

Information and Advice

- 2. At the meeting in March 2015 the Grant Aid Sub Committee agreed a grant aid fund totalling £1.75million per year from 2015-18 to contribute to supporting the delivery of services and activities by the Voluntary & Community Sector (VCS). Within this budget, £16,000 per year is allocated to the provision of summer play schemes.
- 3. The allocation of grants to summer play schemes operates annually and provides opportunities for Nottinghamshire Voluntary Sector Play Schemes to apply for up to £1000.00 to deliver play schemes during the school summer holidays. A small discretionary amount is retained to support applications from new play schemes which fall outside of the standard application window.
- 4. During 2015 the Community & Voluntary Sector team [C&VS] has worked with colleagues in Communications and Marketing to promote the Summer Play Scheme fund via the local press, social media and the NCC webpage. The C&VS team and Youth Service Countywide team [YSC] also contacted previous applicants and other relevant groups e.g. Nottinghamshire Voluntary Sector Partnership and the Play Forums.

Application and Assessment Process

- 5. Applications were invited between 23 March 27 April 2015 and groups were required to demonstrate how their proposed Play Scheme contributes to Nottinghamshire County Council Strategic Priorities. Applications were also assessed against the published eligibility and assessment criteria.
- 6. Twenty-eight applications were received and assessed. In total, the applications requested £25,695 of Grant Aid funding.
- 7. Appendix 1 contains data about the number of applications per district, recommendations and information relating to the groups that accepted and declined their awards In summary:

- Twenty-seven groups were recommended for funding and notified of their award, subject to a satisfactory 'pre-scheme visit' and aged-debt check. The total amount of recommended funding was £16,499.
- All groups that were successful at the assessment stage achieved a satisfactory outcome from the 'pre-start visit' and consequently, 27 groups were offered Grant Aid funding.
- Five groups declined their award as the amount offered was less that what was requested and the groups felt that they could not deliver the scheme on the recommended funding. Therefore, 22 groups accepted their award totalling £15,040 in Grant Aid funding.

Monitoring

8. Technical Specialists from the CYS team carried out and recorded monitoring visits during the play scheme delivery period. Groups were contacted in early September, with a request to complete the online End of Scheme Report by 30 September 2015.

Support to Groups

9. The groups not recommended for funding have been provided with the reason(s) for not supporting their applications and offered support from both the C&VS and CYS Team. Positive relationships have been developed with the Summer Play Schemes and appropriate support and assistance continues to be offered to them. This, for example, includes a general health check and help with exploring ways to reduce costs and generate income.

Programme Developments

- 10. Over the last 2 years, a complete review and revamp of the Summer Play Scheme 'end-to-end' process and forms has taken place in line with the Corporate Grant Aid strategy and in response to budget challenges to make the process more efficient, effective and purposeful. Developments include:
 - Use of technology e.g. introduction of online applications and online end of scheme reporting
 - · Revised assessment tool and process to make it more robust and fairer
 - The introduction of 'pre-start' visits as a due diligence check
 - A revised agreement in line with Corporate requirements agreed with the Legal Services
 - Introduction of a formula for allocating funding, therefore, giving a more consistent, fairer funding allocation.
 - Use of the new corporate database to assist with information management, improve information sharing, financial recording and reporting.
- 11. Looking forward to the 2016 Play Scheme application round it is recommended that it opens in January, which is earlier than in previous years. This will:
 - Allow more time for all stages of the process to be implemented including the pre-start visits and other associated tasks.
 - Enable this committee to approve officer recommendations
 - Enable payments to groups to be made sooner and consequently, enable groups to get everything in place before the start of the summer holidays
- 12. It is recommended that applications are invited to cover 2016 to 2018, which will bring the fund in line with the overall 3-year grant aid programme 26 of 56

Financial Implications

13. These are contained within the report

Reasons for Recommendations

14. The recommendations would bring a number of benefits which include improved confidence and planning for groups who will be better able to build on developments, alongside the Summer Play Scheme rounds being consistent with the 3-year Grant Aid Programme.

This report has been compiled after consideration of implications in respect of finance, equal opportunities, human resources, crime and disorder, human rights, the safeguarding of children, sustainability and the environment and those using the service and where such implications are material they are described below. REPORT OF THE CORPORATE DIRECTOR PLACE SPORTS FUND GRANT AID 2015/16

Purpose of the Report

- 1. The purpose of this report is to:
 - Provide members with an update on the Sports Fund 2015/16
 - Approve the funding recommendations for 2015/16; and to:
 - Seek Members approval to new arrangements for the allocation and approval of the Sports Fund 2016-18.

Information and Advice

- 2. At the meeting in March 2015 the Grant Aid Committee agreed a grant aid fund totalling £1.75million per year from 2015-18 to support projects in the Voluntary & Community Sector (VCS). Within this budget, £36,000 per year is allocated to the Sports Fund.
- 3. The Sports Fund is now a 'one-stop' shop for the Nottinghamshire Sporting Community, with categories for Talented Athletes and Club Development. Within the Club Development category, there are 3 themes that focus on sports participation, developing the coaching workforce and developing Volunteers. Further information about the Sports Fund categories/themes can be found in Appendix 1.
- 4. The Sports Funding was approved as it is recognised that funding to sports groups and individual sports people helps to deliver against NCC's current Redefining Your Council Core Functions, in particular, the Children's and Culture functions.
- 5. Traditionally, the Sports Fund operates annually consequently, sport clubs and individual athletes are awarded grants for one-year only.
- 6. During 2015 the Community & Voluntary Sector (C&VS) team worked with colleagues in Communications and Marketing to promote the Sports Fund via the local press, social media and the NCC webpage. The C&VS team and Sports Nottinghamshire also contacted previous applicants and other relevant groups to inform them about this year's fund.

Application and Assessment Process

7. Online applications were invited between 1st June – 7th September 2015 and applications were assessed by Sports Nottinghamshire colleagues against the published eligibility and assessment criteria.

- 8. Thirty nine Club Development applications were received and assessed. In total, the applications requested over £87,500 of Grant Aid funding Twenty-three sports clubs were recommended for Club Development funding to deliver a total of 37 sports participation, coaching and volunteering projects. The total amount recommended under the Club Development category is £11,300. Appendix 2, Table 1 contains data about the number of Club Development applications by district and the number recommended.
- 9. Appendix 2, Table 2 contains data about the number of Club Development applications by theme, total recommended amount and an overall summary of what the funding will contribute to (the intended outcomes). In summary, the Club Development funding will help sports clubs to:
 - Attract over 500 new participants to sport
 - Keep 600 people involved in sport that would otherwise cease to participate
 - Support over 60 new coaches to achieve a National Governing Body or UKCC level 1 and/or 2 coaching qualifications
 - Recruit and train 100 new sports volunteers.
- 10. Seventy-one Talented Athletes applications were received and assessed. In total, the applications requested £28,400 of Grant Aid funding (the maximum award for this category is £400). Some information provided by applicants is awaiting verification by external bodies, if this is verified
 - 58 applications are recommended totalling £23,200
 - Thirteen applications are not recommended.
- 11. The combined value of Club Development and Talented Athletes applications is £116,300, which totals over three times the available funding. The combined value of recommendations for both categories is £34,500. Appendix 2, Table 3 lists the recommended Club Development applications and provides a brief summary of how each club will use the funding to achieve the intended outcomes. Appendix 2, Table 4 lists the Club Development applications that are not recommended and provides a brief summary of the reason(s) why each application is not recommended. Appendix 3 lists the Talented Athletes applicant names (by district), their sport/discipline.

Monitoring and Support

- 12. Colleagues from Sports Nottinghamshire and approved partners, will carry out and record monitoring visits, as and when practicable for sports clubs, during the funded period. Recipients of Talented Athletes and Club Development funding will be required to complete a monitoring and evaluation form at the end of the funded year.
- 13. The individuals and groups not recommended for funding will be provided with the reason(s) for not supporting their applications and will be offered support from both the C&VS team and Sports Nottinghamshire. Positive relationships have been developed between Sports Nottinghamshire and sports clubs and appropriate support continues to be offered to them. This, for example, includes a general health check and help with exploring ways to reduce costs and generate income.

Programme Developments

- 14. Over the last 2 years, a complete review and revamp of the Sports Fund 'end-to-end' process and forms has taken place in line with the Corporate Grant Aid strategy and in response to budget challenges to make the process more efficient, effective and purposeful. Developments include:
 - a. Use of technology e.g. an enhanced online application form and introduction of online reporting/evaluation.
 - b. A revised assessment tool and process to make it more robust and fairer and a documented assessment process and guidance for assessors.
 - c. A revised agreement in line with Corporate requirements (agreed with the Nottinghamshire County Council Legal team).
 - d. Use of the new Corporate database (One Space), to assist with managing and sharing information as well as financial recording and reporting.
- 15. Looking forward to the 2016 Sports Fund application round, it is recommended that the Club Development category opens in February 2016. This will enable the committee to approve officer recommendations at the May 2016 Grant Aid Sub-Committee. It is recommended that Club Development applications are invited to cover 01 July 2016 to 30 June 2018, which will bring the fund in line with the overall 3-year grant aid programme.
- 16. It is recommended that a small discretionary fund be made available from the overall Sports Fund budget to support sports clubs to achieve specific outcomes during 2017-18.
- 17. It is recommended that the Talented Athletes fund continues to operate annually.

Other Options Considered

18. All the applications received have undergone rigorous assessment and moderation by officers.

Financial Implications

19. These are contained within the report.

Reason(s) for Recommendation(s)

- 20. The recommendations would bring a number of benefits which include improved confidence and planning for sports clubs who will be better able to build on developments, alongside the Club Development rounds being consistent with the 3-year Grant Aid Programme.
- 21. Awarding 2-year Club Development agreements will also have the added benefit of giving the C&VS team and Sports Nottinghamshire time to work more effectively and directly with sports clubs to support them to become more sustainable.
- 22. Due to the unpredictable nature of the athletics (e.g. athletes may not be selected for their squad in year two, they may change sport categories, they may be injured), it is recommended that the Talented Athletes fund continues on an annual basis.

The club will be required to identify the need and receive an endorsement from its Governing Body. A maximum award of £250 will be available for Volunteering Development.
Sports Clubs Coaching	Clubs who are looking to train individuals to become qualified level 1 and 2 coaches will be able to apply for a contribution towards the overall costs. The club will be required to identify need and receive an endorsement from its Governing Body. A maximum award of £400 will be available for Coach Bursaries.
