REPORT OF THE CHIEF EXECUTIVE

APPOINTMENT OF COMMITTEES

PURPOSE OF REPORT

1. To consider the reappointment of the Council Committees.

BACKGROUND

2. Under the Council's Constitution, the Annual Meeting of the Council has to establish such Committees as the Council sees fit.

MATTERS FOR CONSIDERATION

The Cabinet

- 3. Cabinet carries out all of the County Council's functions which are not the responsibility of any other part of the Council, whether by law or under the Constitution. The appointment of individual Members to the Cabinet together with the allocation of portfolio responsibilities is a matter for the Leader.
- 4. Article 7.2 prescribes the composition of Cabinet, which is the Leader, plus at least 2, but not more than 9 other Councillors, each with a portfolio of responsibilities. The Constitution further provides for the appointment of Deputy Cabinet Members without portfolio and without voting rights. The Members of Cabinet may all be drawn from the same political Group on the Council.
- 5. The Leader and the 9 other Cabinet Members are members of Cabinet and have a vote. Deputy Cabinet Members are members of Cabinet but without a vote. Any other Councillors are able to attend Cabinet meetings and only one member from each group is entitled to speak on each agenda item. Any other Members wishing to speak can only do so in exceptional circumstances with the permission of the Chair.

- 6. Under the Constitution the Council currently has the following Committees:-
 - Planning & Licensing
 - Rights of Way
 - Appeals
 - Pensions
 - Audit
 - Personnel
 - Standards
 - Health and Wellbeing Board
 - Corporate Parenting Panel
 - Local Joint Resolutions Committee
- 7. The Council needs to decide whether to reappoint these Committees, either with their current or changed terms of reference. Council also has to fix the size of the Committees and then allocate places to the political Groups.
- 8. Currently there is a Senior Staffing Sub-Committee which is a Sub-Committee of the Personnel Committee. This Sub-Committee deals with the appointment, dismissal and taking disciplinary action against senior officers listed in the Constitution. It is proposed that in future it be mandatory for Sub-Committee members to have received appropriate training.
- 9. Appeals Committee already considers appeals by private, voluntary and independent sector providers of funded early years education provision against decisions by officers to remove them from the County Council's directory of providers. It is proposed to extend this to include appeals against decisions not to include providers in the directory, and to amend the Constitution accordingly.
- 10. In determining the membership of Committees, account must be taken of the requirements of the Local Government (Committees and Political Groups) Regulations 1990 and 1991 made under sections 15 and 16 of the Local Government and Housing Act 1989. These Regulations require that seats on Committees and Sub-Committees are allocated to the political Groups in a way which reflects the overall balance on the Council.

Overview and Scrutiny Committees

11. Section 21 of the Local Government Act 2000 requires that a Local Authority with Executive arrangements establish overview and scrutiny committees. There is no legal requirement for a particular number. However, there is a requirement to identify how the Council's functions under the Health and Social Care Act 2001 will be discharged. Currently the Council has established an Overview Committee and three Standing Committees: Communities and the Environment, Health

and Wellbeing, and Education. Council on 31st March 2011 agreed to the establishment of a Health and Wellbeing Board. To avoid confusion it is proposed to rename the Health and Wellbeing Standing Committee to Social Care and Health Standing Committee

- 12. Any Committee which scrutinises matters related to the education service must by law also include the following non-Councillor Members, who are Statutory Co-optees:-
 - 1 representative of the Church of England
 - 1 representative of the Roman Catholic Church
 - 2 elected Parent Governors
- 13. Currently there is a Joint Health Scrutiny Committee with Nottingham City Council which has responsibility for scrutinising health matters which impact on the Greater Nottingham area. The appointments of a Chair and Vice-Chair of this Joint Committee, together with the roles of Clerk and other Officer support, are undertaken in accordance with an agreement between the County and City Councils. Under this agreement in 2011/12 the Chair will be nominated by the City Council and the Vice-Chair by the County Council.
- 14. There is also currently a Joint LAA Scrutiny Committee with District and Borough Councils in Nottinghamshire, although it has not met for some time. As the Local Area Agreement has been discontinued by the Coalition Government it is proposed to disestablish this Joint Committee.

Joint Committees

- 15. There are also currently three other Joint Committees between the County and Nottingham City Councils as follows:-
 - Joint Committee for Appointments to the Nottinghamshire Police Authority*
 - Joint Committee on Strategic Planning and Transport
 - Greater Nottingham Light Rapid Transit Advisory Committee
- 16. The Joint Committee on Appointments to the Police Authority is a requirement but Council should consider whether to continue with these other Joint Committees. It should be noted that based on the Police Reform and Social Responsibility Bill currently before Parliament, Police Authorities will be replaced by Elected Police Commissioners in 2012. In addition it is proposed in the Bill that there will be a Police and Crime Panel.

Mental Health Guardianship Panel

17. A pool of 16 Members (8 Conservative, 4 Labour, 2 Liberal Democrat and 2 Independent) has been established from which a Mental Health Guardianship Panel can be formed to make decisions on renewal and discharge of guardianship under the Mental Health Act 1983. It is proposed to continue with these arrangements.

Combined Fire Authority

18. The County Council is required to appoint 12 members to the Combined Fire Authority. Appointments must be made in accordance with political proportionality.

RECOMMENDATIONS

Following discussions with the Leader and the other Groups the recommendations are as follows:-

- 19. That only the Leader, Deputy Leader and Cabinet Members be members of Cabinet and have a vote, with Deputy Cabinet Members being non-voting members. Any other Members will be able to attend, and only one member from each of the opposition groups will be entitled to speak on each agenda item. Any other Member wishing to speak can only do so in exceptional circumstances with the permission of the Chair.
- 20. (a) that the Council re-establish the following Committees and Sub-Committees of Council with their existing terms of reference and with the membership shown but that the terms of reference of the Appeal Committee be amended to include hearing appeals by private, voluntary and independent sector providers of funded early years education provision against any decision by officers of the County Council to remove them from the Nottinghamshire directory of providers, or to refuse to include them in the directory:-

- (d) That in addition to the Councillor membership of the Health and Wellbeing Board, the following also be members of the Board;
 - one representative from 2 District Councils;
 - the Director of Adult Services;
 - the Director of Children Services;
 - the Director of Public Health;
 - one representative of Local HealthWatch;
 - one representative from each of the 6 GP Consortia;
 - one representative from the NHS Commissioning Board,
- (e) That the Council make the following appointments of Chair and Vice-Chair until the Annual Meeting of the Council in May 2012, it being noted that the appointment of a Chair and Vice-Chair of the Senior Staffing Sub-Committee shall be a matter for that Committee:-

 - (b) That the Team Manager, Governance and Scrutiny be authorised to act on behalf of the Chief Executive to appoint people as statutory or non-statutory co-optees to membership of committees or joint committees when required.
