<p>Childcare Act 2006 Section 1: This sets out a general duty to improve the well-being of children under five and reduce inequalities.</p> <p><u>National Core Purpose of Children's Centres:</u></p> <ul style="list-style-type: none"> • To improve outcomes for young children and their families, with a particular focus on the most disadvantaged families, in order to reduce inequalities in child development and school readiness. • To support parenting aspirations, self esteem and parenting skills, and child and family health and life chances. <p><u>Children's centres should:</u></p> <ul style="list-style-type: none"> • Assess local needs to identify gaps and opportunities to inform local and strategic planning and commissioning of services; • Provide access to high quality universal services; • Use evidence based approaches to deliver targeted, family-centred support; • Act as a hub for the local community; • Share expertise with other early years settings; • Respect and engage parents; • Work in partnership across professional/agency boundaries. 	<p><i>All children, young people and their families will have the opportunity to fulfil their potential by having the best start in life, and have access to services when and where they need them most.</i></p> <p>Our Ambition is underpinned by the following guiding principles. We will:-</p> <ul style="list-style-type: none"> • <i>Support families to make informed choices about services that build resilience and self-reliance;</i> • <i>Target resources to those children and families with greatest need within a universal service delivery framework;</i> • <i>Ensure that service provision is fully accessible and delivered within local communities;</i> • <i>Listen to children, young people and their families and involve them in decision-making about how best to deliver services;</i> • <i>Consider the needs of the whole family when assessing and responding to the needs of children and young people;</i> • <i>Work with partners to maximise best use of available resources to local communities;</i> • <i>Promote opportunities for voluntary and community participation in the planning and delivery of services;</i> • <i>Support a suitably qualified, skilled and experienced workforce to ensure provision is delivered to a high quality;</i> • <i>Commission services that have been shown to make a difference.</i>

Local Authorities should:

- **Section 5a** – secure sufficient children centres to meet local need;
- **Section 3 & 4** – make arrangements for integrated working; work with health and employment services, particularly JobCentre Plus;
- **Section 5C** – ensure that each centre is within the remit of an advisory board.
- **Section 5E (2)** – consider whether early childhood services should be delivered through the Children's Centre
- **Section 5D** – ensure parents are consulted about any major changes to children's centre provision.
- **Section 98C** – produce and publish an action plan after an Ofsted inspection.

Nottinghamshire's children's centres will be organised on a cluster basis. Each cluster will be structured to have one management and governance structure for all centres in the cluster, whose key accountabilities will be to:-

- Provide leadership, management and coordination of integrated services within a defined neighbourhood that result in measurable outcomes for children and young people aged pre-birth - 5;
- Ensure the provision of efficient, high quality parenting and setting/home-based family support services for children aged 0-12;
- Improve the delivery of services through work with partners as individuals and/or joint working arrangements that result in measurable outcomes for children and young people aged 0-19;
- Establish appropriate and representative governance arrangements for the local area;
- Lead the development, implementation and review of an integrated improvement plan that reflects the strategic priorities and statutory duties in relation to local need;
- Effectively manage the CAF process at a neighbourhood level;
- Manage delegated budgets and resources, including those agreed through commissioned contracts;
- Ensure that services meet national and regulatory standards, including Ofsted and service contract standards.
- Ensure the effective community participation in the management, delivery and review of services, including children and young people.
- Develop a communication and consultation plan for the cluster;
- Contribute to a workforce development plan for the district;
- Provide evidence of the impact services have on children, young people and families.

Secure sufficient childcare places for working parents (or in education or training) <p>National Core Purpose:</p> <ul style="list-style-type: none"> • Provide access to high quality, inclusive early learning and childcare, with particular support to :- <ul style="list-style-type: none"> • childminder networks • provision supported by qualified teachers/Early Years professionals. • All 3 and 4 olds entitled to 15 hours of free early education per week for 38 weeks of the year. 	<p>Children's centres will:</p> <ul style="list-style-type: none"> • Ensure there is sufficient, affordable, accessible, sustainable, high quality childcare available that meets local need; • Support the creation of communication- friendly early learning places; • Provide/support the development of high quality early learning opportunities according to local need, eg Stay & Play, Toddler Groups, etc.; • Provide sessional crèche provision that supports adult based activities; • Support prospective childminders; • Support delivery of Bookstart programmes; • Ensure all 3 and 4 olds have access to 15 hours of free early education per week for 38 weeks of the year.
