# **Scoping Questions – Safeguarding Vulnerable Adults**

The Overview and Scrutiny Committee are asked to consider the following questions when scoping a Scrutiny review:

Issues for Scrutiny should reflect: Concern of Members, the Public or Partners Strategic Priorities for the delivery of services and Clear Outcomes to improve performance, value for money or to iii. change the priorities of the Council. Concern **Improve Priorities** Performance Strategic Plan Members Quality of **Public** Community service Strategy delivered **Partners** Value for money

#### A. Aims

What are the aims of the review (key question?)

To contribute to policy development and review within the safeguarding vulnerable groups agenda. What will the impact be of the wider safeguarding remit and the forthcoming Safeguarding Vulnerable Groups Act 2006 (due to come into force in October 2008)?

How does the review link to priorities?

The Strategic Plan "Altogether Better" 2006-2010 undertakes to safeguard the most vulnerable young people and strengthen community care to help more vulnerable elderly or infirm people live independently at home.

How does the review link to community concern?

The proper protection of the most vulnerable is naturally an issue of public concern.

What outcomes are sought?

Better safeguarding of vulnerable adults and a definitive judgement on whether or not amendments to policies and procedures/services reflect properly the requirements of forthcoming legislation (i.e. proactively protecting the community from the potential for abuse).

Improved partnership working.

Which specific areas will the review examine?

The shift from an adult protection focus to a wider safeguarding remit and its impact on the County and City.

The development of separate safeguarding boards for the City and the County.

The work and remit of the Independent Safeguarding Authority.

The implementation of the Safeguarding Vulnerable Groups Act 2006 (due to come into force in October 2008) across the County and City.

Possible related area: implementation of the Mental Capacity Act 2005 – additionally related to the Mental Health Act 2007.

- Is the service achieving what it set out to achieve?
- What can we improve?
- What are the community's priorities?
- What are the regional/national/international priorities?
- Are we doing what users / non users / local residents want?
- Are users' needs central to the service?
- What are the strategic and operational risks?
- What intelligence is available to predict future change?
- Is there effective partnership working?

Gather evidence from/consult vulnerable service users
