<u>Homestart – Presentation to Grant Aid Sub Committee by Liz Sheldon – Homestart Ashfield</u>

Presentation will cover:-

- What Homestart do and how they work together in Nottinghamshire
- How they work with and support Children's services and other partners
- The difference Grant Aid makes to their organisation

Background

Homestart began life back in 1973 – A worker from the City of Leicester Childrens's department was convinced that volunteers could help families with young children in a variety of settings. They would support the parent as the 'sustaining agent' in the child's life and see the home as the 'sustaining background'. Volunteers would offer individual programmes of support and help, to suit the needs of particular families and give children the best possible start in life.

Today they operate in 288 local communities in the UK and helped develop similar programmes in 22 countries.

The Charity operate a model where each local home start is an independently registered charity, set up and run by people from the local area, and responsible for raising all its own funds. A small local staff team recruits and trains local volunteers and carefully matches them with local families who need support. Each local Home-Start is managed by a board of volunteer trustees.

In Nottinghamshire there are 4 Homestarts working in the County – Ashfield, Mansfield, Newark & Nottingham (Nottingham covers Broxtowe, Gedling & Rushcliffe).

Grant Aid

During the period 2012-15 – NCC provided combined grant aid to the Nottinghamshire Homestarts of £105,000.

The current round 2015-18 we encouraged a consortium application and they were awarded £85,100.

Delivery

Parents are offered support, friendship and practical assistance through home- visiting and group work to improve their understanding of the needs of their children and build resilience to deal with future problems.

Home-Start supports and encourages parents to create better outcomes for their children. Support ing families through difficult times and empowering them to make better choices to provide a happy, safe and stable environment in which their children can grow and fulfil their potential.

Some parents have gone into volunteering which eventually may lead to further education and training, while others have successfully found employment or been supported to remain in employment.

Parenting courses/ confidence building courses are provided

Advice is given on leading healthy lifestyles; volunteers model positive interaction with children; parents are helped to get their children nursery and school ready.

In 2015 they supported 361 families with 678 Children.

REPORT OF THE CORPORATE DIRECTOR OF PLACE

UPDATE ON THE WORK OF THE COMMUNITY AND VOLUNTARY SECTOR TEAM

Purpose of the Report

1. To update members of the Grant Aid Sub-Committee on the work of the Community and Voluntary Sector Team and to approve Grant Aid to three 3 Community & Voluntary Sector Groups providing support to victims of Sexual Abuse.

Information and Advice

- 2. The priorities of the team have been identified as working in partnership with the voluntary and community sector:
 - to improve preventative and core services that help strengthen the local community;
 - · to streamline the corporate grant aid process and
 - to promote localism by working with communities to increase community involvement in the way services are shaped and delivered.
- 3. A key strategic priority for the Council is to ensure that Nottinghamshire has strong communities that are safe and thriving. The reality of the challenges faced means that the Council of the future will be different in the way it is shaped, organised and how services are delivered. The Council is committed to working in partnership with local communities, voluntary groups and volunteers to provide services.
- 4. Work being undertaken by the team seeks to support ways to develop and strengthen engagement with communities, moving towards a changed landscape of local services with new and innovative models being implemented. The contribution made to improving public services and well-being in Nottinghamshire by communities and the voluntary sector is recognised and supported through both an extensive grant aid programme and direct handson support from Community Officers.
- 5. Over recent years economic circumstances have drastically changed how organisations are funded with the result that only well organised third sector groups can thrive and provide a valuable contribution to the local community. Only by being robustly established and equipped to respond to new challenges can the wealth of voluntary sector organisations across the County maximise the positive impact that they have on local communities.
- Through the support of the team and the match funding benefits accrued by County Council
 grants around £1 million of additional funds have been secured by the sector in the past 18
 months.

- 7. The work of the Community and Voluntary Sector Team underpins the Council's commitment to building on its reputation of working in partnership with the community and voluntary sector to help build local capacity. The range and scope of activities which members and officers are involved in seek to help to drive programmes with communities to deliver local solutions and move towards providing services in a different way.
- 8. The Council has several important roles to play in supporting communities to:
 - Build a strong sense of community, capacity and pride through collaborative partnerships.
 - Engage in the planning and delivery of services.
 - Generate and sustain their own capacity to respond to the challenges which Nottinghamshire faces.
- 9. Building confident and stronger communities is especially important within the current climate and the Team has been working with different communities across Nottinghamshire to help support local activities. These activities bring individuals together to celebrate the uniqueness of localities by helping to encourage and empower communities to take ownership and pride in the places they live and the people they live with. Examples of this include:

Hawtonville Community

- 10. Working with Newark & Sherwood District Council to support activity resulting from findings of Neighbourhood Study, the study amongst other things identified a need for community development. Our role includes help to:-
 - Facilitate delivery of the wider priorities identified in the consultation process.
 - Identify local leaders who can contribute to a community orientated body
 - Support / help create a community orientated body to deliver activities
 - Support the management of Hawtonville Community Centre within an agreed framework and target
 - Raise revenue so that provision can be developed

Haven Centre – Stapleford

- 11. A former County Council primary school has been utilised by the Haven Church for the past 18 months delivering a wide range of community services which includes:
 - Youth Group 2 evenings a week with over 50 attendees
 - Mums & Tots Club with Soft Play
 - Performing Arts Club The Dream Centre
 - Debt Advice & Life Skills Project CAB Supported
 - School Holiday Lunch Club
 - After School Club
 - School Holiday Lunch Club
 - Haven Eagles Over 50's Group

- Job club
- Clothes Bank
- Community Choir
- Food-bank
- Furniture Bank
- Homework Club
- Community Café

12. The CVS Team have been working with the Haven Centre and colleagues from NCC Property on a long term arrangement to maintain the community benefits and realise the value of the capital asset for the Council. Work is progressing well and it is hoped that a solution will be considered by the May 2016 Finance & Property Committee.

Bellamy Estate

- 13. The CVS Team with partners have worked with Severn Trent Water to install 2 large sewerage rings on either side of the locked bollard that were sited on the Old Newark Road area in order to reduce fly tipping that was happening on a regular basis. The locked bollard has since been rammed and snapped so these fly tippers are quite determined to continue using the site to dump rubbish.
- 14. The intention is to speak with Severn Trent again to see if they might be able to put a third ring in place to prevent further incidents.

Oak Tree Estate

15. The Fire Service have been working very closely with the Infant School with firefighters supporting the literacy sessions at the school. This is a way of making the children aware of what the Fire Service do and how important it is not to play with matches etc. The partnership group plans to extend this approach and invite the Police and District Council Warden Services to join the initiative. The aim is to have a positive effect on the children where rapport and trust will be built, hopefully reducing anti-social behaviour on the estate.

Coddington Village Hall

16. The local community are looking to refurbish and develop the Memorial Hall, Cllr Dobson asked if there was any help the CVS Team could provide. Details of seven potential grant funding organisations have been provided and the offer of help to submit applications has been made.

Commemoration event - Battle of the Somme.

- 17. 2016 marks the centenary of the Battle of the Somme. The commemoration is being led by the Department for Culture, Media and Sport on behalf of the UK Government in partnership with the Commonwealth War Graves Commission and the Royal British Legion to build a programme of events which reflect the significance of the First World War Somme campaign.
- 18. The Somme was one of the bloodiest battles of the First World War, resulting in over one million casualties. There will be a range of events taking place in the UK and France to mark the centenary period, for which more information will be available in due course. The CVS Team are working on a commemoration event to be held at County Hall on 1 July 2016.

Promoting Community Cohesion

Manton Estate

19. Community Cohesion in Manton has been supported with an award of £10,000 from the Police and Crime Commissioner. Part of the award was used to hold an event on the 19 March 2016. The event was supported by the CVS Team where more than 70 local people, Polish and English joined together to share cultural experiences whilst celebrating Easter and encouraging social integration.

Netherfield Forum Events

- 20. Through the Community & Voluntary Sector Team, the Council is working with the voluntary and community sector to engage them in the planning and delivery of services by helping to build capacity and confidence to drive improvements in quality of life, influence decisions which affect them and consider their role in the delivery of services. This includes:
- 21. Working with the Netherfield Forum the team are supporting two community events provisionally titled "Our Community".
 - Saturday 14 May Loco Youth "Our Community" Open Day
 - Saturday16 July St George's Centre "Our Community" Open Day
- 22. The purpose the events engage the diversity of the local community and help develop a stronger sense of community for everyone. Planning is underway to develop activities that encourage the sharing of experiences incorporating cultural exchanges, language, food, and music. This in turn will strengthen community relations, highlight positive actions and promote social cohesion alongside reducing mistrust and anti-social behaviour.

Community Empowerment & Resilience Programme (CERP)

- 23. Members will be aware that a key part of the CERP was taking forward the findings from the State of the Sector Report produced by Sheffield Hallam University in October 2015. Four events have been held with a combined audience of 300 participants. The key areas for development have been identified:-
 - Coordinating the Sector Voice
 - Enabling Social Action
 - Sector Solutions to the Volunteering Gap
 - Understanding & Mastering Commissioning Success
- 24. The next steps include establishment of cross sector working groups to develop action plans and establish measures of success.

Grants to VCS Groups Supporting Victims of Sexual Abuse

- 25. The Crime Survey of England and Wales reports that Sexual Abuse is experienced by 19.1% of women and 2.7% of men during the course of their lives, the recent high profile cases of historic child abuse has led to an increased demand for services form third sector organisations that provide a range of support services for victims.
- 26. For a number of years the County Council either through the grant aid programme or more recently through Public Health budgets has provided funding to three organisations in the county to support victims of sexual abuse and sexual violence. A re-alignment of public health funding means that the Grant Aid Committee is being asked to approve the following 1 year grants:

ISAS (Incest & Sexual Abuse Survivors)	£13,397
Nottingham Rape Crisis Centre	£23,202
S.H.E (Supporting Healing Educating)	£12,940

27. A request for temporary financing of £49,539 from contingency for 2016\17 has been made. Subject to this Committee's support, this request will be forwarded to Finance & Property Committee for approval.

Other Options Considered

28. None - The grants to the three named organisations are required to ensure the continuation of vital services to the victims of sexual abuse and sexual violence.

REPORT OF THE CORPORATE DIRECTOR OF PLACE

ARTS GRANT AID 2016-18

Purpose of the Report

1. The purpose of this report is to advise Members of the applications received to the Grant Aid Arts Fund and to seek funding approval from Members.

Information and Advice

- 2. The County Council is committed to supporting Nottinghamshire Citizens to benefit from arts projects across the county. The Grant Aid Arts Fund was previously known as the Nottinghamshire Arts Fund. The Fund aims to help local communities to participate in and engage with the arts. It is open to applications from artists, community organisations, or professional arts organisations. As such it is a vital tool in supporting 'grass roots' arts activity. NCC Grant Aid investment acts as a catalyst for new and appealing activities, but it does not make groups reliant on this funding. The result is a sustainable arts sector more able to adapt and respond to opportunities.
- 3. Previously the Arts Fund had two funding rounds each year for awards of between £500 and £2,500. In October 2015, the Grant Aid Committee agreed to a refreshed Grant Aid programme, to bring the Arts Fund in line with the overall three-year funding round.
- 4. A revised process with a new single round in early January 2016 was launched. Applications were invited for funding from £2,000 to £5,000 per year, for two years (2016–18). The total Arts Fund budget for this period is £72,000.
- 5. The published priorities for funding stated that the arts project should:
 - a. Increase the number of Nottinghamshire residents benefitting from community arts activities
 - b. Improve the quality of arts for Nottinghamshire residents.
 - c. Contribute to the Nottinghamshire County Council Strategic Plan: http://www.nottinghamshire.gov.uk/thecouncil/plans/councilplansandpolicies/strategicplan/
 - d. Have in place a minimum of 10% funding from other sources as money or as 'in-kind' support that can be quantified.

- e. Involve one or more professional artists (by professional artist we mean a person who earns more than 50% of their income from their arts practice and / or a person with extensive recent experience of arts projects delivery evidenced in their CV and / or a graduate of an Arts based Degree with at least 2 years' experience in the arts).
- f. Include the specific group(s) / target community in the various stages of the project (e.g. planning, design/development, delivery, monitoring / evaluation)
- g. Have in place effective governance, management processes and practice
- h. Have in place a strategy for how the project will continue beyond the funded period and/or leave a legacy.
- i. Applications that improve access to arts for Nottinghamshire people were particularly welcome. For example:
 - Projects that are not already provided within Nottinghamshire
 - Projects that meet the needs of Nottinghamshire residents / communities that are not already addressed
 - Projects that are delivered within Nottinghamshire at locations where there is currently no or limited arts provision / activity (e.g. the Ashfield and Mansfield districts)
 - Projects that are delivered within Nottinghamshire at times not already covered.
- 6. A total of 53 applications were received, totalling over £441,400 (over six times the available funding). All applications were shortlisted against strict criteria, Details of the shortlisting criteria can be found in **Appendix 1**.
- 7. At least 18,000 Nottinghamshire residents are expected to benefit from this funding programme, which will also be supported by at least 100 volunteers.
- 8. Applications that satisfied the requirements were assessed and moderated against the published criteria by the Arts Development and Community & Voluntary Services Teams. Consequently, a total of 10 applications were recommended for approval.
- 9. Details of all applications and the outcome of the assessment process (including recommendations), are attached as **Appendix 2**.

Financial Implications

9. Budgetary provision is available in the Grant Aid budget.

Reasons for Recommendation/s

10. The applications that have scored the highest in the assessment process are the ones recommended. These applications best meet the published aims and objectives of the Arts Fund Priorities, The Grant Aid Strategy and the NCC Strategic Plan 2014-18.

11. Applications that are not recommended for approval will receive feedback and will be signposted to Inspire and the Art Council for further information and advice.

Shortlisting Criteria	Rationale for Shortlisting Criteria
a. Has the applicant completed the section re: amount of funding requested?	The application is incomplete and it is not possible to assess an application if they have not told us how much money they are asking for.
b. Does the financial data balance?	 Priority is given to applicants who are able to put together a basic projection of financial expenditure, which is also an indication of good project/financial management. If the financial data does not balance, it will not be comprehensive. Consequently, it will be more difficult to understand how the money will be spent – and more time consuming to assess. Note that if the financial discrepancy is minor (e.g. just a few £s out), then this may have been included in the shortlist.
c. Is the 'other funding' confirmed – or mostly confirmed?	 Priority will be given to applications that have confirmed all – or most of their other sources of funding.
d. Is the target audience confirmed?	The application is incomplete and it is not possible to recommend an application if they have not told us who their target audience is);
e. Does the application confirm in whic district they will deliver their project for both years?	 Priority will be given to applications that have already planned where they will deliver their project in both year 1 and year 2. The underlying assumption is that applicants that have identified the district for both years are more advanced in their project plan.
f. Did the applicant submit a CV for each artist listed on the application form?

SUMMER PLAY SCHEME GRANT AID 2016 & 2017

Purpose of the Report

1. The purpose of this report is to advise Members of the applications received to the Grant Aid Summer Play Scheme Fund and to seek funding approval from Members.

Information and Advice

- 2. At the meeting in March 2015 the Grant Aid Sub Committee agreed a grant aid fund totalling £1,750,000 per year from 2015-18 to contribute to supporting the delivery of services and activities by the Nottinghamshire Voluntary & Community Sector (VCS). Within this budget, £16,000 per year is allocated to the provision of summer play schemes.
- 3. In previous years, VCS Summer Play Schemes could apply for up to £1,000 per year to deliver play schemes during the school summer holidays. In October 2015, the Grant Aid Sub-Committee agreed to a refreshed Grant Aid programme, to bring the Summer Play Scheme programme in line with the overall three-year funding round.
- 4. Consequently, the Community & Voluntary Sector Team managed a revised process and launched a new Summer Play Scheme round in mid-January 2016. Leading up to the launch, the Community & Voluntary Sector (C&VS) team worked with colleagues in Communications and Marketing to promote the Summer Play Scheme via the local press, social media and the NCC webpage. The C&VS team and Youth Service Countywide team (YSC) also contacted previous applicants and other relevant groups e.g. the Nottinghamshire Voluntary Sector Partnership and the Play Forums.
- 5. Applicants were invited to apply for up to £2,000 to deliver summer play schemes in 2016 and 2017.
- 6. The Summer Play Schemes are open to Nottinghamshire children aged 5-14 years and applications were required to demonstrate how their proposed play scheme contributes to Nottinghamshire County Council Strategic Priorities.
- 7. Twenty applications were received, (requesting a total of £37,762 of Grant Aid funding). All applications were assessed against the published eligibility and assessment criteria.
- 8. Appendix 1 contains data about the applications and recommendations. In summary:

- Seventeen summer play schemes are recommended for funding, subject to a satisfactory 'pre-scheme visit' and further information.
- The total amount of recommended funding is £25,330.
- The funding will contribute to over 1,200 hours of summer play scheme activities for over 5,860 children.
- 9. Three applications are not recommended as they did not meet the criteria for this fund.
- 10. After the assessment, the C&VS team carried out moderation of the assessments and any queries were resolved with the Youth Service.
- 11. The groups not recommended for funding will be provided with the reason for their applications not being supported and offered support from both the C&VS and YSC Teams. Positive relationships have been developed with the Summer Play Schemes and appropriate support and assistance continues to be offered to them. This, includes a general health check and help with exploring ways to reduce costs and generate income.

Financial Implications

12. Budgetary provision is available in the Grant Aid budget.

Reasons for Recommendations

13. The Play Schemes recommended for approval will provide play opportunities that are safe, high quality, varied and demonstrate how the needs of minority, diverse and excluded groups will be addressed during the Scheme.
