### **DOMESTIC ABUSE SERVICES PROCUREMENT**

The committee had received two reports in relation to the procurement of domestic abuse services. It was explained that the second report updated the proposals for refuge services, and proposed an indicative reduction of £100,000 in the Public Health budget for domestic abuse services.
