REPORT OF THE HEAD OF SCRUTINY

Terms of Reference and Annual Review

Purpose of the Report

1. This report introduces the Committee to its Terms of Reference for 2005/06.

Terms of Reference

2. The Terms of Reference for the Environment & Sustainability Select Committee as defined by Article 6 – Select Committees of the County Council's Constitution, are to provide:

An overview of the Council's performance on environmental protection and sustainability including

- planning,
- transport,
- rights of way,
- engineering and building,
- waste disposal and
- direct service organisations.

Strategic Priorities

3. The Strategic Priorities for this Select Committee will need to be amended in light of the new Strategic Plan which is currently being prepared. The Strategic Priorities below are those taken into account by the Select Committee when devising its programme of work over the last year (see Appendix A).

Environment - We will safeguard the natural and built environment and work for more and better public transport options, better roads, more recycling and less waste.

- Work with partners to reduce waste and achieve more recycling through separate collection of materials, and composting
- Secure a reduction in carbon dioxide emissions by energy conservation and purchase of 'greener' energy
- Improve the County's highway network and work with partners to reduce accidents
- Reduce car usage through the provision of better information on public transport, through the adoption of more school travel plans and by improving bus, rail and tram services
- Raise environmental awareness
- With partners, conserve and enhance the County's outdoor environment, countryside and wildlife.

Environment Targets

- Double our waste recycling rate from 8% in 1998/99 to 16% in 2003/04
- Reduce the backlog of repairs on main roads by 80% over the next four years
- Reduce CO2 emissions from County Council buildings by 25% on the 1998 level by 2003
- Reduce the use of cars for journeys to school from 27% to 25% by 2006
- Cut the number of deaths and serious injuries to children caused by road accidents from 130 per year (1994-98) by 28% by 2005
- Introduce half-hourly daytime services on the Robin Hood Line between Nottingham and Mansfield Woodhouse by 2002/03.

6. A review of scrutiny conducted by the Environment Select Committee during the last municipal year is attached at Appendix A for information.

Extant Sub-Groups

7. **Sustainability Sub-Group**: In early 2004, the Environment Standing Select Committee established an informal sub-group to consider and scrutinise sustainability issues. This was a response to the increasing

interest amongst Elected Members in sustainability and more specifically the Cabinet decision in December 2003 (in a report entitled "Taking Sustainability Forward") to give Environment Select sustainability as part of its remit. The Sub-Group met on six occasions over the last eighteen months or so in order to undertake its main function of scrutinising the delivery of the Taking Sustainability Forward Action Plan.

In addition, the Sub-Group has examined issues around excess packaging and contributed to the County Council's response to the UK Sustainable Development Strategy consultation.

Joint Steering Group – School Travel Plans: The Select Committee also set up a Sub-Group to monitor and oversee the progress of the Government's "Travelling to School Initiative." This is aimed at all schools having a School Travel Plan by 2010.
