MOTION TWO

"The jobless total for 16 to 24 year olds hit a record of 1.02 million in the quarter nationally. Provisional data from the end of September/early October 2011 had 4.6% (1,187 young people) of young people in academic years 12-14 in Nottinghamshire County Not in Education Employment Training (*PM0001- 3rd October2011*), in

Ashfield it is 5.0%, Bassetlaw 6.2%, and Mansfield 6.3% which are all above the County average.

The Government has launched initiatives to help young people into work but what does the future hold for the young people of Nottinghamshire.

Youth unemployment is the highest it has been since records began nineteen years ago causing greater vulnerability within our young people not only across the country but across Nottinghamshire.

This Council calls for the Government to ensure young people receive impartial information and guidance relating to further and higher education, apprenticeships, vocational training and full time employment and access to resources which will enable young people to reach their full potential.

This will ensure all young people of Nottinghamshire receive the high quality support and guidance they deserve."
