**REPORT OF THE SERVICE DIRECTOR FOR TRANSPORT, PROPERTY AND  
ENVIRONMENT****NOTTINGHAM POST – ENVIRONMENTAL AWARDS 2014****Purpose of the Report**

1. This report provides information to the Committee on the recent Nottingham Post Environmental Awards 2014 which was delivered in partnership with the County Council and Veolia (the County Council's waste contractor).

**Information and Advice**

2. The Nottingham Post Environmental Awards 2014 took place at Nottingham's Belfry Hotel on Wednesday 12<sup>th</sup> November to celebrate the exemplar work undertaken by communities, organisations and individuals within the County in the environmental and sustainability sector. The awards, sponsored by Veolia (the County Council's waste contractor), were organised by the Nottingham Post and delivered in partnership with the County Council as well the Nottinghamshire Wildlife Trust.
3. County Council attendees included the Leader of the Council, the Chairman of Environment and Sustainability Committee, the Corporate Director for Environment & Resources and the Service Director for Transport, Property & Environment.
4. The awards recognised the good work and innovation within the sector by communities, business and education, and created a platform to celebrate their success. Schemes included projects to reduce energy bills, projects to protect houses from flooding and farming as a form of therapy for vulnerable people.
5. The County Council is proud to have been able to support this event, in partnership with Veolia. The support shown by the County Council represents a continuing commitment to improving the environment and encouraging sustainability against a challenging financial backdrop.
