REPORT OF THE TEAM MANAGER, DEMOCRATIC SERVICES CIPS 2012 AWARDS BEST PUBLIC PROCUREMENT PROJECT

Purpose of the Report

 To consider the attendance of Councillor Kevin Rostance at the Chartered Institute of Purchase and Supply (CIPS) Awards being held in London on Wednesday 12th September 2012.

Information and Advice

- 2. During the last two years Nottinghamshire County Council (NCC) has undergone a transformation of its entire business including its procurement activity. As of February 2011 a new centralised procurement team has had responsibility for all NCC external spend of circa £500m per annum. The most challenging procurement category in the public sector is Social Care (also the Council's largest spend area of circa £200m).
- 3. This project has helped both Councils and NHS across Nottinghamshire recognise the opportunities and benefits that can be achieved with the support of professional procurement, especially across the Social Care category. This new dynamic creates a solid foundation for joint commissioning opportunities with procurement input in future.
- 4. Nottinghamshire County Council has received a Finalist nomination for the Chartered Institute of Purchase and Supply, and it was thought appropriate that Councillor Rostance should attend the event.
