# UNDERSTANDING THE NATIONAL POLICY FRAMEWORK 10<sup>TH</sup> OCTOBER 2011 LONDON

## 1. Purpose of Report

1.1 To consider approval for the attendance of Councillor C Barnfather and Councillor R Butler at the Understanding the National Policy Framework conference in London on 10th October 2011.

#### 2. Information and Advice

2.1 LG Group and the Planning Advisory Service invites authorities to explore what the National Policy Framework means for them and what authorities need to consider in terms of planning for people, places and prosperity.

This conference will

- Explore the latest developments at national level and what they mean locally
- Unpack the proposed presumption in favour of sustainable development, the duty to co-operate, and the role of evidence in developing plans
- Provide delegates with practical advice and the opportunity to share experience with other practitioners, from the public and professional

This event is limited to 100 delegates, with 2 free places offered to each planning authority on a first come first served basis. Due to the summer holidays and the fact that the next Administration Committee is not meeting until 13<sup>th</sup> September two places have already been reserved.
