REPORT OF THE GROUP MANAGER, PROPERTY ASSET MANAGEMENT

RADCLIFFE BARN FARM - GRANT OF A RENEWAL FARM BUSINESS TENANCY FOR FARMHOUSE AND BUILDINGS WITH PASTURE

Purpose of the Report

1. To approve to grant a new short term Farm Business Tenancy.

Information

- 2. This report contains an exempt appendix, which is not for publication by virtue of paragraph 3 of Schedule 12A of the Local Government Act 1972 (as amended) (Information relating to any individual and the business affairs of a particular person (including the authority holding that information)). The exempt appendix provides details of the terms agreed. Disclosure of this information would prejudice the parties' commercial interests.
- 3. The site comprises farmhouse and buildings with pasture land of 22.11 acres as identified on the attached plan.
- 4. The grant of a renewal agreement is to ensure occupation of the property and maintain the agricultural condition of the land along with providing a short term rental income.
- 5. The terms for a new tenancy have been provisionally agreed and the details are contained in the exempt appendix to this report.

Consultation

6. The Cabinet Member for Economic Development and Asset Management and Ward Member have been consulted on this proposal.

Other Options Considered

7. Longer term strategy is being considered for the site and a new tenancy is preferable to the site being vacant.

Reason for Recommendation

8. The grant of a renewal agreement is to ensure occupation of the property and maintain the agricultural condition of the land along with providing a short-term rental income.
