

## **REPORT OF THE DIRECTOR OF PUBLIC HEALTH**

### **JOINT STRATEGIC NEEDS ASSESSMENT (JSNA) CHAPTER: CANCER, SUPPLEMENTARY APPENDIX FOR BASSETLAW**

#### **Purpose of the Report**

1. To seek approval from the Health & Wellbeing Board for a supplementary appendix describing cancer services within Bassetlaw, in line with recommendation G of the previously approved Joint Strategic Needs Assessment (JSNA) chapter on cancer.

#### **Information**

2. In January 2019, the Health & Wellbeing Board considered the Cancer JSNA chapter. This JSNA chapter outlined the current position in relation to cancer across Nottinghamshire and in reference to the national position for England, including local incidence, mortality and survival. The chapter is available to view on [Nottinghamshire Insight](#).
3. The JSNA chapter described the prevalence and incidence of cancer for the whole of Nottinghamshire, as well as discussing cancer survivorship and the impacts on social care. Bassetlaw cancer risk and need were therefore covered fully in the JSNA chapter. However, the list of service assets described in the JSNA chapter did not include those in Bassetlaw. The JSNA chapter recognised this, and identified that in terms of specific cancer services, Bassetlaw details would need to be addressed in an additional supplementary appendix. A recommendation was therefore included in the JSNA that a supplementary appendix for Bassetlaw should be provided. This recommendation was approved by the Health & Wellbeing Board.
4. The supplementary appendix is complete. This document lists the cancer services in Bassetlaw and describes service user views on these services. The document has been quality assured and endorsed by the Doncaster & Bassetlaw Cancer Programme Board.

#### **Other Options Considered**

5. None. Completion of a supplementary appendix for Bassetlaw was an approved recommendation within the approved Cancer JSNA Chapter.

#### **Reason/s for Recommendation**

6. To fulfil the approved recommendation G of the Cancer JSNA chapter, to provide a supplementary appendix on cancer services in Bassetlaw.

## **Statutory and Policy Implications**

7. This report has been compiled after consideration of implications in respect of crime and disorder, data protection and information governance, finance, human resources, human rights, the NHS Constitution (public health services), the public sector equality duty, safeguarding of children and adults at risk, service users, smarter working, sustainability and the environment and where such implications are material they are described below.
