Purpose of Report

East Midlands European Office (EMEO) Stakeholder Group

England's East Midlands European Office represents a variety of regional stakeholders, including strategic regional bodies, local government and universities.

EMEO acts as an interface between these partners, on the one hand, and the European Institutions and the multitude of Brussels-based interest groups, European regions and networks on the other. In addition, EMEO plays a role in making valuable connections within the East Midlands.

Managed by the East Midlands Development Agency (*emda*) on behalf of the wider partnership, EMEO is committed to offering the highest quality service, enabling the voice of the region to be heard on the European stage.

Nottinghamshire Training Network

NTN is a not for profit, membership based organisation. Their network consists of 7 local colleges, 8 national training providers, 17 local training providers, 2 local authorities and 5 support organisations who are all involved in delivering work based learning, apprenticeships and support for approximately 8,000 learners, servicing and supporting over 6,000 local businesses.

Arts Partnership Nottinghamshire

Arts Partnership Nottinghamshire (APN) is a partnership between the 9 local authorities across Nottinghamshire (city and county). The Partnership works with local residents and organisations to help young people benefit from positive and inspirational experiences in the arts.

APN brings together partners working across a range of fields relevant to young people's lives, including arts, youth, inclusion, health, education, community safety.

The ambition long term is that young people will be fully involved in the partnership as decision-makers, creating a dynamic and lasting partnership which genuinely puts young people at the heart of youth arts development across Nottinghamshire. The Partnership are actively working with young people across Nottinghamshire - city and county - to empower them to take an active role in arts development locally.

Samworth Church Academy Governing Body

The Samworth Church Academy is a comprehensive 11-18 secondary school situated on the outskirts of Mansfield on the site of the former Sherwood Hall Comprehensive School. It opened in September 2008 and

is the first 'academy' to be created within the Nottinghamshire Local Authority area. The Academy operates independently of the Nottinghamshire Local Authority and receives its funding directly from central government.

The core governing body is made up of appointed governors and elected governors and in addition to this further co-options may be made. The sponsors for the Samworth Academy are David Samworth and the Diocese of Southwell and Nottingham and as such the sponsors appoint four 'sponsor governors' each and the single 'Local Authority Governor' is appointed by Nottinghamshire County Council. In addition elections are held for two 'parent governors' and a 'staff governor' and all other 'co-opted governors' must be appointed by the full governing body. The Governing Body will meet regularly as required for the efficient running of the school and at least once per term but typically governors may anticipate around six to eight meetings a year.

The regulations state that governors must meet a range of eligibility criteria. For example at the time of appointment governors must have attained 18 years of age and must consent to an application being made to the Criminal Records Bureau for an enhanced-level criminal records certificate. No individual may serve as a 'Governor' if they are bankrupt or work at the school for more than 500 hours per year and the term of office is four years from the date of appointment. The Local Authority Governor may resign the appointment by giving notice in writing to the Clerk to the Governors and this will have immediate effect unless a period of notice of up to one month was specified in the notification.

Sutton Centre Academy Governing Body

The Sutton Centre Academy (SCA) is sponsored by West Notts College, and Nottinghamshire County Council has chosen to be a co-sponsor. This means that the Council is entitled to appoint two Local Authority Governors to the board of Governors. Due to regulations regarding proportions of governors the Council is unable to appoint more than one voting governor at present, but should be able to appoint a second voting governor once the Academy has been open for a short while, e.g. one term.

It is expected that the initial (shadow) Governing Body will be inaugurated in the Autumn Term 2010 so as to gain a run-in before the Academy opens (currently planned to be Jan 2011).
