Recommendation 1 (of 16)

The Select Committee recommends that in order for the Council to take advantage of all the opportunities offered by the 2012 Games that a Member Champion be appointed. This role would be supported by a steering group, consisting of a lead officer plus 4 or 5 key officers representing sport, culture, education and economic development from within the County Council and would develop a strategic partnership with Nottingham City Council. This would enable the development of a county wide joint strategy, facilitating integrated programming, better coordination and joint working. This should be a time limited group working together to ensure a coherent response to the opportunities available. The Committee recommends that the Member Champion gives regular updates to the Council and reports to the Overview and Scrutiny Committee at yearly intervals.

The portfolio holder agrees that given the potential of the 2012 Olympics and Paralympics to inspire a whole generation of people throughout Nottinghamshire, it should be afforded a high degree of political and officer support.

The appointment of a Member Champion would show that the Council is serious about their intention to take advantage of the opportunities prior to, during and after the games. As this area of work moves forward, it will be important that the Member Champion, with supporting cross-departmental officers, link into existing 2012 structures, at a regional and sub-regional level.

The process for appointing a members champion is currently being finalised. It has been suggested that the role could be added to that of the portfolio holder for culture and regeneration, although there may be other options. A formal endorsement of the appointment will be taken through the appropriate channel at the earliest opportunity.

The "lead officer role" requires further clarification as currently this area of work does not

appear in any current job description. Other authorities around the Country have appointed a dedicated officer to develop the work strands and build strategic partnerships. Further work is required to determine the level of priority the Council wishes to give to this area of work and consider the resource implications.

County Council and City Council officers are already engaged in Olympic sub regional steering committees organised by EMDA and managed by the county sports partnership director. It is possible for the emerging County Council steering group to have a direct influence on the work of the countywide group.

The local production of promotional material, including logos linked to the 2012 Games, is fraught with danger and could lead to a legal challenge from the Games organisers. There is detailed guidance available relating to brand protection, as a large proportion of the budget for the Games will come from commercial sponsorship.

Whilst the brand protection policies should not deter the Council from investigating the scope in this area, the Council will need to secure an input from the professional communications/marketing teams, internally and externally. It will, however, be important internally that a "one stop" shop for advice in this area is coordinated by the corporate communications team.

Recommendation 3 (of 16)

The Select Committee considers the funding for young people identified as future participants in the Olympics and Paralympics is inadequate and recommends that the criteria used in the Grant Aid Guidelines be reconsidered. Consideration should be given for the £100 'top up award' to be discontinued, athletes in receipt of this will already be receiving funding from their governing bodies, and the money should be redistributed amongst the other recipients.

The criteria and guidelines for the County Council grant aid scheme for talented sports people is reviewed annually to take into account the changes made by other agencies who grant aid in this area. Any review also takes into account any changes the County Council may wish to make in relation to specific targeting of resources and overall resource availability.

It would be possible to set a new specific set of criteria to support potential Olympians and Paralympians but, as Portfolio Holder, I would not want to see current funding diverted from the level of performer it is currently directed at (representing Nottinghamshire nationally in both Olympic and non-Olympic sports)

None of the current recipients of grants from the County Council receive money directly from their Governing Body in the form of grants and the County Council policy has been in place since the introduction of the Sports Lottery Fund.

The level and type of support for Olympic and Paralympic hopefuls for 2012 and 2016 differs dramatically from the support afforded through the Council's current grant scheme. Full consideration will be given to costing and recommending a new grant programme dedicated to supporting Nottinghamshire's most talented sports people and I have requested Officers to start work on this.

The Committee feels that the County Council's Arts Service is well placed to coordinate a Nottinghamshire wide approach and that a public/private/voluntary partnership should be formed to work up detailed proposals.

Recommendation 7 (of 16)

Members of the Select Committee considered the use of training facilities by teams from smaller, less wealthy countries. It recommends that a "package" for these teams which could include not just access to training facilities but hospitality and support service arrangements, transportation, interpreters and security be developed. The Select Committee considers that the presence of elite athletes may act as a catalyst for young people to become interested in and participate more in sport. It recommends that negotiations with teams expressing an interest in using facilities in Nottinghamshire be undertaken to encourage them to become involved in the local community and sports clubs, for example by allowing access to their training activities, running taster or training sessions. The Committee recognises that the Council would need to consider the possibility of a new funding resource to make this happen.

The hosting of international teams for training and pre-games holding camps is a complex issue. Nottinghamshire has faired well in securing a range of facilities to be included in the 2012 formal publication of quality assured venues, which will be distributed to counties in Beijing. These include, amongst others, Nottinghamshire County Cricket Club at Trent Bridge, The Jesse Boot Basketball Centre in the City, facilities at Ashfield School and the National Water Sports Centre. The Select Committee's recommendation to focus on smaller, less wealthy countries is welcomed by the Portfolio Holder, however it is recognised that this targeted approach is more difficult to coordinate.

The County Council has a place on the sub regional 2012 partnership and it is this forum that will look towards acting as a coordinating body for requests to use facilities in Nottinghamshire. This would not discount direct approaches to specialist facilities, such as Holme Pierrepont, but it will be important not to duplicate effort in such a complex arena.

There are currently no resources dedicated to negotiating with national teams and it is unlikely that the smaller teams will give consideration to 2012 preparations until after the Games in Beijing. This also applies to the major countries, who may well be based outside of Nottinghamshire, but require specialist facilities as part of an overall package. This is already the case in relation to the Loughborough University bid to host the USA National Team.

Finally in this section, it is also recognised that a proactive ambitious scheme to support nations to use facilities in Nottinghamshire falls outside the scope of a single service or department and will

require a full Council commitment for any ambitions to be achieved.

Similar targeted activity will take place following the extra investment into schools and the Olympics and Paralympics will create a range of opportunities to link with the new 5 hour physical education and sport offer in and around schools.

I have already instructed Officers to commence work to establish a coordinated events strategy.

In terms of school based facilities, the County Council should celebrate the considerable investment and achievements that have been made in this regard, whilst recognising that it is a challenge that is becoming more difficult due to a variety of factors. These include: Foundation status, Private Finance Initiatives (PFI), a reduced Joint Use budget and the remaining 5 year time span of the Joint Use agreements.

Increases in participation on school sites can only be achieved by a joined up approach to the Building Schools for the Future (BSF) programme and ensuring that community access to new facilities is built in at concept and planning stages.

There is a commitment through the LAA process for sports partners to work together to increase participation levels in sport and active recreation and it is believed that the 2012 games will add impetus to this objective.

With regard to the pressure on local teams and clubs in relation to insurance payments, a specific piece of work will be commissioned to investigate if the Council's own insurance scheme is the appropriate vehicle to alleviate the problem.

Information about local travel options.

Easy access to travel information will be fundamental to the promotion of local attractions in Nottinghamshire. Existing tourism information services, such as the internet site 'visitnottingham.com', already contain detailed information about attractions in Nottingham and how to travel to these attractions using the integrated journey planner. It is likely that visitors to Nottingham during the Games will be seeking information about travel to London, as well as 'what to do' locally, during any spare time they may have. There will be a clear need to signpost visitors to appropriate information sources. It is also likely that many visitors will be using predominantly public transport and the County Council will need to coordinate its information provision with tourist and travel information points, as well as public transport operators, in the City and County. It will be particularly important to target points within easy reach of the Central and East Coast Lines to London, where visitors to the Games would be most likely to stay.

Additional Transport Provisions

Any additional measures to improve transport infrastructure and provision to Nottinghamshire's tourist attractions would need to be commensurate with a pragmatic assessment of the potential increase in tourism resulting from the Olympic Games, and whether this would warrant supplementing existing services. Discussions will need to be held with public transport operators to understand what additional provisions they will be making – for example, these are likely to be enhanced rail and coach services to London - and what complementary provisions would be required locally.

The County Council is represented on the Nottingham Station Hub Steering Group. The Council's Rail Officer has asked for this issue to go on the agenda for the next Steering Group meeting, and will set out to the Steering Group the concerns of the Select Committee. The County Council will request that the works schedule for the station improvements takes steps to minimise disruption during the Olympic period.

The Council's Rail Officer will also:

- raise with East Midlands Trains the need to assess whether additional services might be required from London to Nottingham, or extra capacity on existing services, particularly in the evenings, and
- raise with Network Rail the need to avoid any disruption to rail services during the Olympic period, and so not to schedule any routine maintenance on the Midland Main Line

The Select Committee would encourage Experience Nottingham to look at preparing plans to attract visitors to Nottinghamshire at an earlier date to enable it to take advantage of the opportunity to increase visitor numbers offered by 2012. It should consider the possibility of attracting spectators to use the county as a place to stay during the Games and to visit before and after 2012. Developing a marketing strategy to operate during the Games to encourage visitors to return at a later date should also be explored.
