County Council workers receive safeguarding training that will equip them to identify risk, and offer support to children and young people who live in homes where they witness domestic violence, or where are involved in abusive relationships.

The impact on the safeguarding of children and young people be thoroughly examined when reductions in service provision, or funding for domestic violence support services, are proposed.

2. There will be a new Training Plan linked to the Domestic Violence Framework described in answer to recommendation 1. This plan will include domestic abuse safeguarding training. The County Council staff groups that need this training will be clearly identified. Information about access to training courses should be displayed in the intranet. Outcomes should be monitored to assess how far this has been achieved.

The following is already provided for staff working in children's services: Training Courses regarding domestic violence are provided by the Nottinghamshire Domestic Violence Forum (NDVF). These courses are free to professionals working in Nottinghamshire and Nottingham City. The regular NDVF emails containing information about the training are circulated via the Nottinghamshire Safeguarding Children's Board (NSCB) Training Sub-Group and training pool members for wider distribution across agencies. The NSCB training programme also signposts colleagues to where they can find the NDVF training information. In 2010/11 the NSCB developed and provided a "Trilogy of Risk" course which considered risks to children where one or more of the following factors are present:-

- domestic violence
- mental health
- parental substance misuse.

Issues regarding domestic violence are also contained within the core courses run by the NSCB. A further event based on the "Trilogy of Risk" course will be provided during 2011/12.

3. Nottinghamshire Safeguarding Children's Board has advised partners, including the County Council, to examine the impact on safeguarding of any reductions in the funding of domestic violence services, as recommended.

The risk and impacts of changes have been explored through the Consultation processes for Supporting People.

Children's Social Care has maintained its investment in working with the specialist domestic violence sector to embed specialist domestic violence workers within its reception and assessment team, to enable them to provide a professional and expert service to vulnerable children experiencing domestic violence on their own homes. In addition, Children's Social Care continues to work with the police to gain a better understanding of the appropriateness of referrals to children's social care regarding issues of domestic violence. This work is reducing the number of inappropriate referrals and thus allowing those children who require Children's Social Care intervention to receive it in a more timely way. Team support workers are currently embedded within the Police Public Protection Unit and there is an ongoing review of the effectiveness of these posts. A further report on the impact of funding reductions on children affected by domestic abuse will be submitted to the NSCB in July 2011.

Children referred to Children's Social Care as a consequence of domestic violence are provided with advice and information as well as additional emotional and behavioural support as required through the service's reception and assessment teams which have embedded specialist link domestic violence workers. Through these workers children and young people can access individual work, group work and a range of appropriate advice and guidance information.

- 3) There have been no further reductions to services since July 2011. Key areas of delivery are currently subject to a competitive tendering process designed to increase efficiency and quality of response to domestic violence.

4. There is a budget from Nottinghamshire Children and Families and Cultural Services and NHS Nottinghamshire and Bassetlaw PCTs of £110,000 for this work in Nottinghamshire for 2011-12. It has been reduced by 15% from 2010-11. Some provision is available in each district but the demand exceeds supply and supply is reducing.

Mainstream services such as schools, youth service, social care are unable to give the level of support required even when staff have expertise in this area (which many do not) so they refer on to these specialist services, demonstrating the need for them. Evidence show that they do make a difference to future outcomes particularly in relation mental health.

This is a key concern of the Community Safety Portfolio Holder.

Both the Youth Justice/Targeted Support Service and the Young People's Service undertake direct work with young people at risk of and/or experiencing domestic violence, on both an individual and group basis. This work is usually focused upon prevention and harm minimisation. Both Services, along with other children and young people's services, refer cases, as appropriate, into the Council's key arrangement for accessing early intervention focused support for children and young people – the network of 42 locality based multi-agency joint access teams (JATs).

In addition services such as the Early Years and Early Intervention Service work directly with families where domestic violence may be present. Here, the Service is also represented on JATs, and is also leading work to redefine and reshape the Council's family focused support services both to minimise gaps in provision and to ensure key issues such as domestic violence are addressed by Council services.

4) The services for children's outreach described above are currently subject to a tender process so will continue at the current level for at least 2 further years. Additional funding for children who disclose domestic abuse to staff at their school has been identified and commissioned, thus extending the hours of support available.

Work with parents is available in North Nottinghamshire funded by a Lottery Grant to Nottinghamshire Womens Aid. Some support is available elsewhere via the "Freedom Programme" delivered in Children's Centres and by Probation.

5. Programmes are available for children and young people but providers may need to charge for their delivery – the level of provision varies according to availability of funding. Schools cannot be required to include this education within the school programme and some do refuse even when funding is available. Bassetlaw Secondary schools have consistently engaged with this programme with funding from Bassetlaw PCT.

Community Safety funding is being sought to improve the number of school programmes running this year, especially within high crime "priority areas". We already know that Brunts School, Samworth .Academy, Sutton Community College and Quarrydale School are planning "Healthy Relationship Programmes" covering domestic violence and teenage partner violence in the coming year.

6. This can be recommended for schools but not mandated under existing conditions. Guidance for Schools in dealing with issues of Domestic Violence of which it is aware amongst its pupil cohort has been produced and it is anticipated that this will

be available via the Schools' Wired System by the start of the next academic year in September 2011.

Dayncourt School in Rushcliffe, has been selected for a pilot project funded by Comic Relief to develop a "Whole School Approach to Domestic Violence". The results of this 2 year pilot will also be shared on the Schools' *Wired* System.

8. A series of meetings have been scheduled to explore possibilities in relation to future funding. The budget holders are recommending more joined-up approach to commissioning and a reduced number of contracts. Since this may impact on services in local areas, a consultation proposal on this issue is going to Cabinet in July. The proposal is for this consultation to be conducted during August and September to seek views on a number of options. The results would go to Cabinet in October 2011.

With regard to overall funding levels a reduction of 18% has been made in the total allocation of funds from local partners in the current year as compared to the previous year. However the impact of the reductions to the Supporting People Budget (in Adult Social Care) will be felt strongly next year resulting in a total budget reduction (if other funds remain constant) of 28%. Since there is a strong possibility that other reductions will be made next this could rise to over 30% in just 2 years.

The impact of commissioning changes and budget reductions will be assessed over time and Members kept informed

8) The joint commissioning process has been designed by a group of officers across the Council agreed and with Portfolio Holders and Cabinet. The process was subject to a consultation exercise with stakeholders in August/September 2011 and adapted in response to the replies received to arrange services into 2 lots, covering North and South Nottinghamshire. The services went out to tender, jointly, in November 2011 and applications were returned in January. The outcome will be known in April 2012. The jointly commissioned services will be started in August 2012

9. This issue is very complex.

The consultation proposal on future commissioning, see above at 8, will include options for reducing the number of services in each area that are funded through public funds.

Where there is a clear business case this approach is already being developed as with MARAC provision in 2011. However the 7 domestic violence specialist voluntary sector organisations in Nottinghamshire are all still delivering a range of services using public, private and charitable funding. There is a great deal of local support for these organisations and valuable expertise contained within them. They are independent organisations. Funding decisions can limit the number of providers but this also introduces a competitive environment and overlap of delivery on the ground because agencies no longer have mutually exclusive catchment areas.

At the present time a dual approach is being followed:

Encouragement to merge and some commissioning directed to a smaller number of providers.

Service improvement within existing providers via the DV Services Review in order to raise overall standards and limit the effects of competitive commissioning.

12. MARACs are being retained and developed but the available funding has been reduced by 18% due to financial constraints across the partnership

The situation is under review by Safer Nottinghamshire Board with respect to risk of harm and effectiveness of the risk assessment processes used to select the highest risk cases for MARAC. Developments in information sharing between the Police, Social Care and Probation are showing that where a victim is willing to engage, effective agency responses can take place earlier, before the MARAC meeting. This results in a reduction in the number of cases that need the MARAC process.

At this stage it is not possible to extend MARAC to include medium risk cases however more could be done to support the survivors concerned through both police systems, other mainstream services and specialist outreach services should money be made available. Medium risk victims need secure and effective specialist services outside the MARAC to be continued. This includes the refuge and outreach services where reductions of 30% and 50% respectively are due to take place over the next 12 months.

This recommendation is only partially accepted because the Safer Nottinghamshire Board does not have capacity to extend MARACs to include Medium Risk at the present time.

#### 13 and 14.

Work has been done through the Domestic Violence Services Review to ensure that the Women's Aid 24 Hour Domestic Violence Helpline is promoted effectively as the main referral route for all agencies in Nottinghamshire.

In the current year the Women's Aid 24 Hour Domestic Violence Helpline has lost the

following funding from Nottinghamshire that was provided in 2010-11:
NHS Nottinghamshire PCT £25,000
South Notts Community Safety Partnership £25,000
NCC Grant Aid is providing £28,000 instead of the previous £30,000

So a total loss of £52,000 in a single year.

The Helpline is continuing using Big Lottery, Nottingham City Council, and Nottingham PCT supplemented by their own reserves for a limited period.

More money is needed here but it is mainly partnership funding that has been lost, not County Council funding. The Portfolio Holder for Grant Aid is unable to help at present since the Grant Aid funding for 2011/12 is fully committed. However, this is something members may wish to consider for the 2012/13 through the Members Reference Group.

The July report to the Nottinghamshire Safeguarding Children's Board recommends that this issue to be raised at the Children's Trust and the Health and Well-Being Board.

16. Co-location of Independent Domestic Violence Advocates, Adult Social Care and Children's Social Care with the Police Domestic Violence Support Unit is already being explored and has been partially implemented in Mansfield. The Police are following a model developed in Cornwall that has proved effective. Supt Helen Chamberlain, force lead for Public Protection, is now addressing a county and force wide approach to these developments which is taking some time but should be completed in 2012.

The newly implemented ACPO risk assessment has been introduced countywide and further training is planned in the autumn to ensure all practitioners are able to use this effectively.

This response includes contributions from the Portfolio Holders for Adult Services and Community Safety.

17. Progress within primary health care is being piloted in Mansfield by NHS Nottinghamshire County. In secondary care some training is available at Kings Mill and QMC Emergency departments and a new post has been created within the Healthcare Trust (Mental Health) to deliver training.

When public health functions are moved into the County Council it may be possible to influence this further from within ASCH. The closer link with health and awareness raising will be addressed through Joint Commissioning arrangements and through the work of the Health and Well-Being Board.
