REPORT OF THE CABINET MEMBER FOR COMMUNITY SAFETY COMMISSIONING DOMESTIC VIOLENCE REDUCTION SERVICES

Purpose of the Report

1. The purpose of the report is to seek Cabinet approval for new commissioning arrangements for domestic violence reduction services.

Information and Advice

- 2. On 27 July 2011 the Cabinet gave approval for an eight week public consultation on the future commissioning of domestic violence reduction services.
- 3. Cabinet noted that currently the Council commissions the following domestic violence reduction services under separate arrangements, either solely or in partnership.

4. The consultation has now been completed, 19 responses have been received and two consultation events have been held with partner organisations, existing service providers and service users.

- 5. Four options for future commissioning were proposed with advantages and disadvantages outlined for each option. An Equality Impact Assessment was included with the consultation to ensure that the needs of all potential victims of domestic violence were taken into consideration.
 - Option A: Single County model delivered by 1 service provider
 - Option B: North and South model delivered by 1 or 2 service providers
 - Option C: Three Area model delivered by 1 to 3 service providers
 - Option D: Four Area model delivered by 1 to 4 service providers.
- 6. Feedback from the consultation indicated preferences for Options B and C. Service users emphasised that services must be easily accessible, secure and reliable. The feedback received will inform the commissioning process.

Other Options Considered

7. There was considerable support for Option C and the merits of this have been fully investigated. A common response from those who favoured this option was the need to ensure that services are embedded in local communities. This will also be built into the commissioning requirements.

Reason/s for Recommendation/s

- 8. The consultation revealed close support for Options B and C and it is clear that both have merits. However, after considering the advantages and disadvantages of both options and the feedback from the consultation, Option B is recommended for the following reasons:
 - It aligns services directly with MARAC* geographical boundaries. This means that victims who: are at the most risk of serious harm; need refuge provision; require ongoing support in the community and support for their children will be able to access these from a single organisation.

- It offers greater potential for efficiency savings in relation to back office functions, management costs, contract management and monitoring.
- It offers greater potential for more efficient and effective ways of working between statutory agencies (such as Children's Services and the Police) and domestic violence service providers.
- * Multi Agency Risk Assessment Conferences (which provide targeted support for those victims who are assessed at being at the most risk of serious violence).

Statutory and Policy Implications

9. This report has been compiled after consideration of implications in respect of finance, equal opportunities, human resources, crime and disorder, human rights, the safeguarding of children, sustainability and the environment and those using the service and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

RECOMMENDATION/S

- 1) The future commissioning of domestic violence reduction services by Nottinghamshire County Council is organised into a single commissioning process and divided into two contracts: a North Nottinghamshire contract for services in Mansfield, Bassetlaw, Newark and Sherwood and a South Nottinghamshire contract for services in Ashfield, Broxtowe, Gedling and Rushcliffe.
- 2) The new joint commissioning process for County Council and partnership funded domestic violence reduction services will take place over the next six months led by Nottinghamshire County Council.
