1. Introduction

The following report details the streetlighting work undertaken by Central Networks for Nottinghamshire County Council during the period 1st March to 31st May 2005.

This report is split into two sections, of which the first details the streetlighting faults work that we have undertaken, followed by the new connections activity in the second section. Reference is also made to the new National Service Level Agreement trial that is currently underway – a detailed explanation of this is in the next section.

2. The National Service Level Agreement Trial

The previous report introduced this OFGEM initiative. Also known as the NSLA the objective is for all DNO's across the country to report on their streetlighting work in a consistent format. It was envisaged that the trial would run for 6 months, after which OFGEM would devise a common set of targets and criteria to which the DNO's will have to work. The trial started on the 1st April, and Central Networks have been reporting against this since then.

In many areas, the new criteria are very similar to those agreed with our customers 2 years ago. The main difference now is the way that we now report them on a template designed by OFGEM which allows all local authorities to compare their performance with every one else in this area.

Due to this introduction this report contains information in 2 formats. Firstly information for March under the old standard of service followed by information for April & May under the new standards of service.

3. CN Streetlighting Faults Performance

This section provides summary information for the streetlighting faults reported to Central Networks over the last quarter. They information is split into those received in March under the 'old' standards of service, and those received in April & May under the new standards.

3.1. Faults March

For March these are reported as 'Normal' with a 20 day standard for repair and 'Urgent' with a 15 day standard for repair. The following information details the work done.

3.1.1. Normal Status

Total number of Normal status jobs received is 28 of which:

- 26 were or will be complete within the 20 day standard of service (96%)
- 1 was or will be complete outside the 20 day standard of service (4%)

3.1.2. Urgent Status

Total number of Urgent status jobs received in March is 5, of which:-

- 4 were completed within the 15 day standard of service (80%)
- 1 was completed outside the 15 day standard of service (20%)

3.2. April & May Faults Performance

The new criteria introduced by OFGEM are for *Single Unit Faults*, and *Multiple Unit Faults*; the recommended standards for which are 15 days and 5 days. Prior to the 1st April faults were split into Normal and Urgent status. The new criteria do not distinguish between these categories.

3.2.1. Single Unit Faults

Total Number of single column faults received in April & May is 82 of which:-

- 69 were completed or are still within the 15 day standard of service (84%)
- 13 were completed or are over the 15 day standard of service (16%)

3.3. Faults Commentary

With the information being split between 2 formats it is difficult to compare figures directly. This being the case our performance in streetlighting faults has improved since the last quarter.

In our last report I reported that the Public Lighting Faults Manager would be assuming responsibility for all streetlighting faults from July 2005, from our 'Repairs & restorations' section where it currently sits within Central Networks. This date has slipped, and is now likely to take place in August.

From this time Public Lighting will start the process of taking direct control of faults repair teams, and the emergency callouts.

4. CN Public Lighting New Connections Performance

Similar to our faults performance, the information for this will be reported in 2 sections – March, and then April & May. The figures detail the actual amount of columns that we have been requested to work on rather than schemes.

4.1. New Connections in March

Total number of New Connections jobs received in March is 226 of which:-

• All are complete (100%)

4.2. New Connections April & May

New connections are now split into 2 categories, these being:

- Schemes of 1 10 columns for which the standard of service is 15 days
- Schemes of 11-50 columns for which the standard of service is 25 days.

The total number of jobs received in April & May was 170. Of these 170 fall into the '1-10 column' category. 76 are complete, of which:-

- 35 in under 15 days
- 40 in 15 30 days
- 1 over 30 days

Consequently received volumes are low which has meant our timescales for connection are low. This year is no different For a number of years we have been putting pressure on the lighting authorities to spread their lighting work programme more evenly over the year, and whilst our timescales are low, this is the time to get your connections made, and so avoid the traditional 'last quarter rush'
