## LOCAL PENSIONS BOARD - UPDATE

## **Purpose of the Report**

1. To provide a progress update on arrangements for the Local Pensions Board.

### Information and Advice

- 2. County Council established the Local Pensions Board for Nottinghamshire on 26 March 2015. The Board is responsible for assisting the County Council in its capacity as pension scheme manager to secure compliance with pension legislation, and for ensuring the effective and efficient governance and administration of the local pension scheme.
- 3. The Board was established with a membership of 8; 4 'employer' representatives and 4 'scheme member' representatives.
- 4. Two 'employer' representatives have now been appointed; Councillor David Kirkham for Nottinghamshire County Council and Councillor Sarah Piper for Nottingham City Council. Letters have been sent to all employer organisations requesting expressions of interest for the remaining two 'employer' seats, and the unions have been asked to make a nomination. A verbal update will be provided at the meeting if any further appointments have been made by that date.
- 5. An article about the Board is to be published in the next edition of Nest Egg magazine. The article will invite expressions of interest for the remaining 'scheme member' seats. Nest Egg is circulated to pension scheme members and published on the Pension Fund website.
- 6. The Board will require professional advisory support in respect of the preparation of reports and the provision of advice. Quotations are being invited from external specialists in respect of this support; costs will be met from the annual £25,000 budget approved by Council on 26 March. External support is considered the most cost-effective option as the workload generated by the Board would not justify creation of a post. An external appointment also demonstrates independence.
- 7. The first meeting will take place as soon as practicable after the membership has been finalised. The Board will agree a work programme at that meeting which can then be taken into account when finalising training arrangements.

9. To update Members on progress to date in recruiting members to the new Local Pension Board.
