Purpose of Report

APPOINTMENTS TO OUTSIDE BODIES

1. To consider the changes to appointments to outside bodies

Background

- 2. The Council makes appointments to a number of outside bodies, on a local, regional and national basis. These bodies include charities, limited companies and partnership organisations. The term of appointment varies between the various bodies.

- 5. Greater Nottingham Partnership is now in the process of voluntary liquidation and should be removed from the list once it has been removed from the Companies House Register.
- 6. Industrial Communities Alliance to be removed from the list as Nottinghamshire County Council is no longer involved with the organisation.
- 7. Mansfield 2020 Ltd to be removed from the list as Nottinghamshire County Council is no longer involved with the organisation.
- 8. Nottinghamshire Partnership to be removed from the list as it has ceased to exist.
- 9. North Nottinghamshire College Board of Corporation to be removed from the list as the College currently does not require a representative from Nottinghamshire County Council
