ARTS & SPORTS GRANTS 2012/13 - FINAL ALLOCATIONS

Purpose of Report

1. The purpose of this report is to provide information to Members on the portfolio of arts & sports grants awarded in 2012/13 to date.

Background

- 2. The Nottinghamshire Arts Fund provides grants for between £500 and £2,500 to support arts activities that are led locally, deliver a range of outcomes and secure additional external partnership funding. The projects must be specific and time limited, ensuring that they do not become seen as revenue grants. The Nottinghamshire Arts Fund replaces several other larger grant schemes previously available. This report provides an update on awards from Round 2 of 2.
- 3. The Community Sports Fund (CSF) is a grant aid scheme aimed at helping local sports clubs and organisations, by supporting new projects that encourage additional people to get involved in sport. The maximum award is £1,500. This report provides an update on awards from Round 2 of 2.
- 4. The aim of 'Shining Stars' is to support talented athletes who are currently performing at an international level within their sports. The maximum award is £1,500 for tier one athletes, with an award of £550 being made to second tier athletes. This report provides an update on the application process to date.

Nottinghamshire Arts Fund

5. To the end of Round 2 (closed to applications October 2012) the Arts Development Team received 13 applications with a total request of £28,711. There was £13,615 available to award. The service recommended the award of 7 grants totalling £13611. Please see table 1 below for more details of awards.

REPORT OF THE TEMPORARY GROUP MANAGER SAFER AND ENGAGED COMMUNITIES

EXTENSION OF GRANT AID AGREEMENTS FOR BE-FRIENDING

Purpose of the Report

1. The purpose of this report is to seek approval to extend 8 existing grant aid agreements for organisations that deliver be-friending services.

Information and Advice

- 2. The 2011-15 Corporate Grant Aid Strategy agreed by full Council on 3rd November 2011 recommended that where possible grant aid agreements should be made with organisations for a period of three years.
- 3. However, when awards were recommended for 2012/13 a number of groups offering befriending services were only approved for 1 year. This recommendation was made because colleagues in Adult Social Care and Health were planning a review of home based support services in 2012.
- 4. In September 2012, the Council took the decision to delay the planned tender for home care and other home based support services. This was in order that fuller consideration is given to the range and nature of services that will be needed in future and the best way to deliver these services.
- 5. Following further consideration, a decision has been taken to also delay the planned tender for prevention services so that a comprehensive tender will be undertaken.

Other Options Considered

6. As part of the County Council's Grant Aid Strategy as outlined above it is not appropriate to consider other options at this stage.

Reason(s) for Recommendation(s)

7. To allow continued delivery of a range of be-friending services across the county.

8REPORT OF THE TEMPORARY GROUP MANAGER SAFER AND ENGAGED COMMUNITIES

INFRASTRUCTURE GRANT AID 2013 TO 2015

Purpose of the Report

1. The purpose of this report is to seek approval to agree a two-year (2013-2015) grant aid agreement that contributes to a range of infrastructure services supporting the community and voluntary sector of Nottinghamshire.

Information and Advice

- 2. As part of the Corporate Grant Aid Strategy, funding for Infrastructure groups was recommended and agreed by the Members Reference Group in March 2012, it was also agreed that any grant aid funding, applied for and awarded post 2013 would be allocated on a 2 year basis, therefore aligning with, the 3 year grant aid agreements for the majority of groups which are in place up to 2015.
- 3. At the September 2012 Grant Aid Sub-Committee members agreed that a consortium/partnership approach to delivery of infrastructure support should be encouraged.
- 4. Appendix 1 is a copy of the invitation to apply. This was advertised on the County Council website and shared across community and voluntary sector networks. The application window ran from 15 October 2012 to 7 December 2012. In addition to the advertised material an open event for any potential applicants was held on 31 October 2012.
- 5. As a result of this approach a single application was received by the closing date. This application came from Networking Action for Voluntary Organisations (NAVO) acting as the lead organisation with the following 10 member organisations:-
 - NAVO Lead Body
 - Northern Infrastructure partnership (Ashfield Voluntary Action, Bassetlaw CVS, Voluntary Action Broxtowe & Mansfield CVS)
 - Southern Alliance Infrastructure partnership (Gedling CVS, Newark & Sherwood CVS & Rushcliffe CVS
 - Rural Community Action Nottinghamshire
 - Community Accounting Plus

- 6. The application submitted sought to describe how the partners would contribute to the following 8 areas:-
 - Supporting Nottinghamshire County Council priorities
 - Increase the number & quality of Volunteering Opportunities
 - Support collaborative working & communication
 - To support and manage consultation with the local VCS
 - To provide professional financial and legal support to the sector
 - Build the capacity of the sector through information and training
 - To provide support to the isolated and Rural CVS
 - To identify gaps in provision and help shape and deliver local services
- 7. The application has been assessed by officers in the Community and Voluntary Sector Team and from Adult Social Care and Health and is considered to be of good quality, describing both how services will be delivered and how they will be measured.

Other Options Considered

8. Delivery of this service was sought through an open application process, no other applications were made, therefore no other options have been considered.

Reason(s) for Recommendation(s)

9. Since the application sought a lead body that required them to establish partnership arrangements, we are satisfied that the proposed consortium is an appropriate mechanism for delivering Infrastructure support.

Statutory and Policy Implications

10. This report has been compiled after consideration of implications in respect of finance, equal opportunities, human resources, crime and disorder, human rights, the safeguarding of children, sustainability and the environment and those using the service and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

- Approve a post application discussion with the lead body (NAVO) to agree a set of priority outcomes/performance measures.
- Approve a grant aid agreement to the value of £185,000 from 1 July 2013 to 30 June 2014, and a second year of £165,000 for the period 1 July 2014 to 30 June 2015.

Nottinghamshire Voluntary & Community Sector Infrastructure Grant Aid 2013/15

Nottinghamshire County Council is inviting applications for grant aid funding from Voluntary and Community Infrastructure Organisations. This grant aid is available to contribute to the provision of effective and targeted support for the wider voluntary & community sector of Nottinghamshire.

The Council has provided £185,000 in grant aid to Infrastructure groups for 2012/13 and wishes to continue to support infrastructure groups by making up to £350,000 available for the period 1st July 2013 to 30th June 2015 (£185,000 in 2013/14 and £165,000 in 2014/15)

We are looking for collaborative/partnership bids that cover the period 2013/15 that can deliver countywide services contributing to outcomes against the following criteria.

- To support the County Council's strategic priorities www.nottinghamshire.gov.uk/thecouncil/plans/councilplansandpolicies/strategicplan
- To help increase the number and quality of volunteering opportunities in Nottinghamshire
- To enable communication and collaboration by encouraging sharing of resources to create more effective ways of working. This includes providing forums and networks to share good practice and expertise to be able to, for example, bid for public service commissioned contracts
- To represent the diverse views of local groups to statutory agencies and promoting two way communication on policy developments, service redesign and working in partnership
- To provide support to voluntary and community groups to manage their finances effectively
- To raise standards by providing access to information on governance, funding, legal advice, training and quality assurance, so enabling many groups to acquire and maintain the knowledge, skills and resources they need to support the local community
- To provide developmental support to voluntary and community groups working in rural areas
- To identify any gaps in service provision and fill them by working with new groups to address unmet need and ensure that existing groups are equipped to tailor their services to changing needs

We are looking for applications from a **Lead Organisation** that can demonstrate partnership arrangements that will see the above criteria delivered consistently across the county.

They will work with partners to develop an application and be responsible for working with the County Council and partners to develop appropriate proportionate monitoring arrangements.

You are eligible to be a Lead Organisation if you meet the following criteria:

You are an infrastructure organisation. By infrastructure organisation, we mean civil society organisations whose main or only purpose is to support the work of other groups in the voluntary and community sector. This purpose will usually appear in the governing document of your organisation or will be apparent from the work you have carried out. If supporting other organisations is not an explicit purpose in your governing document doing such work must be within the scope of the work your governing document allows you to do.

You are one of the following types of organisations:

- a registered charity
- a voluntary and community unincorporated charitable association
- a community benefit society registered as an industrial and provident society
- a community interest company
- an organisation of another type if you operate as a social enterprise and principally reinvest your surpluses for social benefit.

You are not eligible to apply if you:

- are a statutory organisation such as a school or local authority, including statutory organisations that have charitable status
- are an individual or sole trader
- make a surplus or profit which is not principally reinvested for social benefit
- are applying on behalf of another organisation a bid writing organisation.

We expect all partners to meet the eligibility criteria above. A partner is defined as an organisation that has some responsibility for delivering the service outcomes.

Applications are invited using the application form (web link) and the closing date for completed applications is 7th December 2012.

SUPPORTING THE VOLUNTARY SECTOR

Purpose of the Report

- 1. The purpose of this report is twofold:
 - To seek approval for funding from the Grant Aid budget to provide a package of financial support to struggling voluntary and community groups including Community Resource Centres in Nottinghamshire
 - To seek approval to support a programme, in conjunction with the Big Lottery to work with voluntary and community organisations to provide technical, business and financial investment to help embed business acumen and thereby greater sustainability across the sector in Nottinghamshire

Information & Advice

Maximizing County Council Grant Aid

- 2. Members have, at previous meetings of this Sub Committee, discussed options for allocating any remaining unallocated monies in the grant aid budget. Members have been particularly keen to maximise the grant aid budget to provide support to locally based voluntary groups working with communities, who are at risk of reducing or, at worse closing their service and so in many cases creating greater difficulties for vulnerable citizens who rely on these voluntary services.
- 3. At a previous meeting of this Sub Committee, Mick McGrath, East Midlands Regional Head of the Big Lottery made a presentation on the work of The Big Lottery in Nottinghamshire and discussed with Members opportunities for working with the County Council to support the voluntary and community sector in Nottinghamshire.
- As a result, the Community and Voluntary Sector Team Manager has met with The Big Lottery to develop a programme of support and funding to struggling groups across the county.

Community Resource Centres [CRCs]

5. Over previous years, the County Council has supported as many as 20 CRCs in any one year through both financial investment and with technical support. During 2011/12, 10 CRCs received County Council support. This support focused on enabling these facilities to make the journey from a full dependency on grant aid support to one where trading income is to the fore, making them more resilient in changing times. The County Council's investment has been made both financially and practically.

- 6. Unfortunately as the economic climate has worsened, the impact on the voluntary sector, including CRCs has resulted in them refocusing their priorities, whilst facing more demand from local communities. The CRCs generally are organisations that act as a key link between the people within a community, the delivery of local services and a wide range of statutory, voluntary, private and indeed faith-based sector activity and generally provide bases for "making things happen".
- 7. They all use a mix of volunteer and staff time to effectively manage these facilities whilst allowing people to be involved directly from their community. They do this whilst seeking to maintain their facilities through the employment of business models and the securing of trading income, a solution which for some is a constant struggle due to barriers such as location, the quality of the facilities, local income patterns and a generally difficult financial environment.
- 8. While CRCs vary in their objectives, they share a number of commonalities in that mostly they are:
 - locally owned and managed as independent organisations and as such are registered with Companies House as companies limited by guarantee and / or have charitable status;
 - can be differentiated from those community centres run directly by the statutory (eg District and Parish Councils) sector;
 - provide a wide and diverse range of services and facilities for their respective local communities – a one-stop-shop approach – which differentiates them from single-focus agencies;
 - in general CRCs mostly have assets in the form of the community building, being in their direct ownership or on long leases and they serve communities where local people are keen to make things happen and to respond to local issues
- 9. A review was commissioned by the Grant Aid sub-committee has found significant projected financial shortfalls and a gap in support for vulnerable communities in ever increasingly difficult times, it is recommended that given the valued and important role these CRCs play within communities that the Centres are invited to apply for support from the grant aid budget.
- 10. The CRCs identified are organisations that the Community & Voluntary Sector team are aware of and continue to work with to varying degrees offering what can be described as "in-kind" support. There may be other groups across the county that would meet a broad definition of Community Resource Centre/Community Hub.
- 11. This will be supported by a joint programme of help, guidance and investment with the Big Lottery as outlined above

Reason/s for Recommendation/s

12.To maximise targeted joint working at locality level to support the voluntary and community sector, including the CRCs, to continue to support vulnerable individuals and communities. This programme, whilst requiring a 'one off' contribution from the Grant Aid Budget will provide a model of good practice and a legacy for collaborative working

Statutory and Policy Implications

13. This report has been compiled after consideration of implications in respect of finance, equal opportunities, human resources, crime and disorder, human rights, the safeguarding of children, sustainability and the environment and those using the service and where such implications are material they are described below. Appropriate consultation has been undertaken and advice sought on these issues as required.

RECOMMENDATIONS

14. It is recommended that

- A joint approach between the County Council and the Big Lottery to developing a programme of practical and financial support to struggling VCS groups in Nottinghamshire is approved
- The sum of £94,000 is allocated from the Grant Aid Budget to support this programme
- This funding is made available from a transfer from the underspend in the staffing element of the Grant Aid budget 2012/2013

NOTTINGHAMSHIRE COUNTY COUNCIL AND THE COMMUNITY & VOLUNTARY SECTOR – THE NOTTINGHAMSHIRE COMPACT

Purpose of the Report

 The purpose of this report is to agree a replacement for the "Nottinghamshire County Compact" a document that sets out how Nottinghamshire County Council and Voluntary & Community Sector Organisations will work together for the benefit of the communities and citizens of the County.

Information and Advice

- 2. In 1998 the first "Compact" was produced by Government detailing a set of guiding principles for working effectively with the community & voluntary sector. A Nottinghamshire version of the Compact was agreed the following year.
- 3. In 2008 Nottinghamshire County Council alongside major public sector organisations in the County signed up to the "Nottinghamshire County - COMPACT – All together better" - this Compact was agreed as part of the Nottinghamshire Partnership.
- 4. In September 2010 the Coalition Government renewed the Compact between Government and the Community & Voluntary Sector, encouraging local areas to follow the principles and refresh local Compacts.
- 5. In September 2011 The Rt Hon Eric Pickles MP, Secretary of State for Communities & Local Government, produced a Best Value Statutory Guidance document which set out some reasonable expectations of the way local authorities should work with voluntary & community sector groups.
- 6. In November 2011 the Grant Aid Members Reference Group received a short paper on the ways the County Council was working collaboratively with the Community & Voluntary Sector much of the practical engagement we are engaged with embraces the principles of the compact & statutory guidance.
- 7. In September 2012 through the Voluntary Sector Liaison Group we consulted VCS representatives about the status and role of the Compact. This consultation was prompted by two things, firstly that we had established through the Local Government Association that 97% of Local Authorities had a "live" Compact and that our Compact was

- under the auspices of the now dissolved Nottinghamshire Partnership, in effect we had no arrangement in place.
- 8. The feedback from VCS colleagues was that there would be no appetite for a major piece of wide consultation to produce another document. They also advised us that a small sub group of the VCS network had already produced some short guidance on shared principles around good practice which could be shaped to become a new Compact – Appendix 1.

Other Options Considered

9. None

Reason(s) for Recommendation(s)

10. Currently we have no Compact and having a set of recorded principles would help us to be in line with government policy.

- Differences of opinion will arise, but we are committed to resolving them in a constructive and respectful manner
- The independence of the voluntary and community sector is crucial to the development, delivery and scrutiny of quality services
- Voluntary and community organisations are entitled, regardless of funding sources, to act as advocates in challenging and seeking changes in public policy
- We need to be active in ensuring that minority ethnic and other disadvantaged groups are included in our consultation and policy development processes so that their views are heard and their concerns acted upon

- Operate commissioning and funding processes (including de-commissioning or grant withdrawal) which recognise the sector's need to operate efficiently and effectively
- Recognise that liaison and consultation need time and money. The VCS cannot undertake these activities at the expense of service provision. A clear protocol on consultation arrangements must be agreed and liaison and consultation must be paid for
- Recognise the complexity of the sector and the broad range of views and groups representatives have to reflect. Pay to support proper representative processes and use the channels that are created
- Recognise that small, local groups have an important voice. Support the VCS in channelling that voice so that it is heard particularly by supporting the infrastructure leadership role
- Allocate resources against clear and consistent criteria in an open and fair process. Use the VCS quality standards in agreed monitoring processes

- Participate in liaison and review meetings to ensure that users, volunteers, members and supporters are informed and consulted, as appropriate, about activities and policy positions.
- Select and support representatives. However, a representative must say when he/she is speaking for him/herself or their organisation or on behalf of a wider network. Furthermore, the representative should report back to his/her organisation or network and other relevant interested organisations
- Help and encourage joint working between small and excluded organisations
- Develop quality standards appropriate to the sector, and put in place the leadership and policies for promoting best practice and equality of opportunity in activities, employment, involvement of volunteers and service provision

Effective Dispute Resolution

Despite best intentions, disputes arise and sometimes threaten important relationships.

Wherever possible, disputes and disagreements should be resolved amicably. The process of resolving disputes amicably between local partners is an important part of strengthening on-going relationships between the sectors.

Prevention is better than cure – if there are concerns around funding or relationships with the County Council it should be addressed before it becomes a problem.

The organisation/s concerned should discuss the issue with the County Council and try to resolve the issue amicably between them.

We agree to keep it professional and to involve outside help if needed.
