





SPORTS GRANT AID 2013-14

Purpose of the Report

1. The purpose of this report is to advise members of the background and process for the allocation of grant aid to sports and to consider the recommendations at paragraph 11.

Background

2. The Corporate Grant Aid Strategy 2011- 2015 agreed the continuation of the following three strands of grants to sports:

Community Sports Fund (CSF) - Sports groups **Rising Stars** - Individuals **Shining Stars** - Individuals

- 3. Grant aid was approved as it is recognised that funding to sports groups and individual sports people helps to deliver against NCC's current priorities, specifically, fostering aspiration and promoting the economic prosperity of Nottinghamshire.
- 4. Grants made under the CSF are for projects with specific outcomes, such as engaging more people in sport, with defined beginning and end dates. In this way, NCC grant-in-aid invests in groups to act as a catalyst for new and appealing activities, but it does not make groups reliant on this funding. The result is a sustainable sports sector more able to adapt and respond to opportunities.
- 5. As grants awarded are for specific projects with beginning and end dates, as in the case of CSF, these grants do not follow 3 year agreements and run to a different funding timetable to other corporate grant aid streams.
- 6. All three strands use an online application process hosted on NCC's website. Assessments are made by a panel of officers using a scored decision matrix. The current system has worked well in providing assessing officers with the right information on which to base funding recommendations.

Current Processes

Community Sports Fund (CSF)

7. The CSF is a grant aid scheme aimed at helping local sports clubs and organisations, by supporting new projects that encourage additional people to get involved in sport. The maximum award is £1,500. The total fund is £16,000.

8. CSF has two rounds of funding, each with a notional allocation of £8,000. **Appendix 1** provides a summary of successful applicants and **Appendix 2** is spreadsheet showing all round 2 applicants to the fund and the outcome of the assessment. Please note all sports and arts grants are one off awards with no further commitment from NCC.

Shining Stars

- 9. The aim of 'Shining Stars' is to support talented athletes who are currently performing at an international level within their sports. The maximum award is £1,500 for tier one athletes, with a reduced amount being made to second tier athletes. The total funding available in this category is a maximum of £25,000 for 2013/14. **Appendix 3** is a table listing all applicants to the fund and the outcome of the assessment.
- 10. Shining Stars has one round which opens for applications in the autumn each year. This grant scheme was conceived in the run up to London 2012 Olympic and Paralympic games. This will be the last award and the grant scheme is to be closed.

Community Sports Fund

The Community Sports Fund allocates £16,000 in grants over 2 rounds of funding. £10,022 was distributed in Round 1 to 8 clubs.

8 applications are being recommended for funding from Round 2. Details are shown in the table below:

Over the past few years the scheme has become extremely over subscribed. For example, the Sports Service received applications requesting in excess of £32,000 for the latest round of the scheme.

Evaluation and monitoring undertaken from the 13 projects which concluded in January 2013 have evidenced that sports participation levels and volunteering had increased. In total over 700 participants benefited from the Community Sports Fund with approximately 100 new people engaging in sport as a direct result of the funding. The projects also included up-skilling over 50 of the volunteering workforce through various leadership programmes.

REPORT TITLE: GRANT AID - ARTS 2013-14

Purpose of Report

1. The purpose of this report is to provide information to Members on the arts grants recommended for awards from the Nottinghamshire Arts Fund.

Information and Advice

- 2. The Nottinghamshire Arts Fund provides grants for between £500 and £2,500 to support arts activities that are led locally, deliver a range of outcomes and secure additional external partnership funding. The projects must be specific and time limited, ensuring that they do not become seen as revenue grants. The Nottinghamshire Arts Fund replaces several other larger grant schemes previously available. The total funding available each year is £42,000. This report provides an update on awards from Round 2 of 2.
- 3. To the end of Round 1 of 2 (round 1 closed to applications May 2013) the Arts Development Team received 10 applications with a total request of £19,260. There was £21,000 available to award in this round. The service recommended the award of 8 grants totalling £14,324. These were approved by the Grant Aid Sub-Committee in September 2013.
- 4. Applications for Round 2 of 2 opened on 2nd September and closed on Monday 21st October. We received 31 applications in total including ineligible and late applications. A table of all applications received is included as Appendix 1.
- 5. The reasons for why so many applications were received in this round and so few in the previous round are unclear. However, one inevitable implication for Round 2 applicants is that many good projects will have to be turned down due to greater competition.
- 6. Following assessment projects recommended for funding are listed below as Table 1. Project scoring over 30 points on assessment have been recommended for funding.
- 7. Applications from arts organisations Live Music Now and Bamboozle Theatre were received and assessed. Both applications scored over the 30 point threshold. Bamboozle Theatre is a specialist theatre company delivering accessible and inspiring work to young people with profound learning disabilities. Live Music Now is a national company developing music projects for older people. As both projects support some of the development objectives of

the Arts Service, these projects will be developed in partnership with the Arts Service and supported as commissioned projects.

EXTENSION OF GRANT AID AGREEMENTS FOR BE-FRIENDING

Purpose of the Report

1. The purpose of this report is to seek approval to extend 8 existing grant aid agreements for organisations that deliver be-friending services.

Information and Advice

- 2. The 2011-15 Corporate Grant Aid Strategy agreed by full Council on 3rd November 2011 recommended that where possible grant aid agreements should be made with organisations for a period of three years.
- 3. However, when awards were recommended for 2012/13 a number of groups offering befriending services were only approved for 1 year. This recommendation was made because colleagues in Adult Social Care and Health were planning a review of home based support services in 2012.
- 4. In September 2012, the Council took the decision to delay the planned tender for home care and other home based support services. This was in order that fuller consideration is given to the range and nature of services that will be needed in future and the best way to deliver these services.
- 5. Although the home based support services tender is going ahead, the prevention and befriending part was taken out and is now under further consideration, probably to go out to tender later this year.
- 6. In order to keep these important grant funded services in place it is proposed an extension to cover 2014/15 is approved.

Financial Implications

- 7. The groups listed in appendix 1 are currently in receipt of grant aid and an extension for 2014/15 is recommended. It is proposed that the award for 2014/15 is reduced by 10.76% this builds in the planned reduction applied to all the three year agreements.
- 8. The grant will be funded from the 2014/15 grant aid budget.

Other Options Considered

9. As part of the County Council's Grant Aid Strategy as outlined above it is not appropriate to consider other options at this stage.

Reason(s) for Recommendation(s)

10. To allow continued delivery of a range of be-friending services across the county.

 - the extension of the 8 befriending grant aid agreements for a further 12 months from 1 July 2014 to 30 June 2015
 - the amount awarded to each group is reduced by 10.76% this is in line with the planned reduction in the Grant Aid budget for 2014/15.
