MEMBER ATTENDANCE AT CONFERENCES AND SEMINARS AND OTHER COUNTY COUNCIL BUSINESS / OFFICERS' TRAVEL OUTSIDE OF THE UNITED KINGDOM

(a) <u>MEMBER ATTENDANCE AT LOCAL GOVERNMENT ASSOCIATION</u> (LGA) RURAL COMMISSION MEETING ON 7 SEPTEMBER 2010 AND LGA RURAL CONFERENCE ON 8 SEPTEMBER 2010, CHESTER

The Chair highlighted that the later agenda item on Appointments to Outside Bodies included the proposed appointment of Councillor Laughton to the Local Government Association Rural Commission.

During discussions, Members requested that some form of guidance to enable greater consistency in decision-making about Member attendance at conferences and training events be drafted and discussed further with Group Leaders.
