#### REPORT OF THE CHIEF EXECUTIVE

## <u>Appointment of Councillor Members to the Nottinghamshire Police</u> Authority

#### 1. Purpose of Report

1.1 To consider the appointment of Councillor Members to the Nottinghamshire Police Authority in the light of the result of the recent County Council elections and the period of office of certain Members.

#### 2. Information and Advice

- 2.1 The Joint Committee last met two years ago following the City Council elections in 2003 to determine the political composition of the Nottinghamshire Police Authority having regard to the political balance of the two Councils taken as a whole.
- 2.2 New Members of the Joint Committee may find the following explanation of the background to how the nine Councillor Members on the Police Authority are appointed useful. On the basis of statistical information for the City and County Councils on population, precept and electorate it was previously agreed by the Joint Committee that the County Council would provide seven Councillor Members and Nottingham City Council two. The political balance of the nine Councillor Members was then determined having regard to the political balance of the two Councils taken as a whole.
- 2.3 Following decisions made at the last meeting of the Joint Committee and appointments made since then, current appointments and terms of office can be set out as follows:-

- 2.4 In the light of the outcome of the recent County Council elections it is now necessary to undertake a further review of Police Authority membership and the remainder of the report deals with this matter.
- **2.5** Following the County Council elections the political composition of the two Councils has changed and is as set out in the table below.

2.6 On the basis of the revised figures in the table above and rounding percentages to the nearest whole number, the following political composition is arrived at:-

Conservative – Two Members (rounded down from 2.36) Labour – Six Members (rounded up from 5.60) Liberal Democrats – One Member (rounded up from 0.89) Independents – 0 Members (0.15).

- 2.7 In the circumstances, therefore, the Joint Committee needs to consider the appointment of five Labour Members and two Conservative Members from the County Council.
- 2.8 In connection with the period of office for these appointments, it is suggested that these be made for four years.
- 2.9 With regard to the task of appointment, I again attach information received from the Local Government Association setting out guidance for those bodies who have responsibility for appointing members of Police Authorities. Although this guidance on skills and competencies was issued in 2002, it remains relevant to the task in hand.
- **2.10** The attention of the Joint Committee is also drawn to proposals set out in the White Paper "Building Communities, Beating Crime a Better

Police Service for the 21<sup>st</sup> Century" issued in November 2004, which, if adopted, will have implications for the future composition of the nine Councillor Members on the Police Authority.

- 2.11 The current arrangements would be replaced so that of the nine Councillor Members, three places would go to the Unitary Council in the police area (the City Council), two to the County Council and four to the District Councils. Furthermore, the Councillors with Cabinet responsibility for Community Safety in the City and County would be Police Authority Members. The second County place and the four District Council places will be selected with regard to the political balance and geographical spread. It is understood that these proposals are still under review following the General Election.
- 2.12 When consultation on these proposals was held earlier in the year, the County Council expressed reservations which are set out in the background paper referred to in this report. At the time of writing this report, I am not aware of any views expressed by the City Council.

## 3. **RECOMMENDATION**

- 3.1 That consideration be given to the appointment of seven Councillor Members from the County Council, comprising five Labour Members and two Conservative Members, for a period of office of four years expiring on 1<sup>st</sup> June 2009.
- 3.2 That the position with regard to possible changes to membership of Police Authorities, as set out in paragraph 2.10, 2.11 and 2.12 of the report, be noted.
