PROPOSED APPOINTMENT OF A DEPUTY POLICE AND CRIME COMMISIONER

Purpose of the Report

1. To enable the Panel to review this proposed senior appointment by the Police and Crime Commissioner.

Information and Advice

Background

- 2. Schedule 1 of The Police Reform and Social Responsibility Act 2011 requires Police and Crime Panels to hold confirmation hearings for Police and Crime Commissioner's proposed appointments to the posts of Chief Executive, Chief Finance Officer and Deputy Police and Crime Commissioner.
- 3. After taking up office on 22 November 2012, the Police and Crime Commissioner has subsequently notified the Host Authority (Nottinghamshire County Council) of his proposal to appoint Chris Cutland to the post of Deputy Police and Crime Commissioner. As a result, the Panel must now review this proposed senior appointment via a confirmation hearing.
- 4. The Commissioner's formal notification of the proposed appointment will be circulated to Members and published on Nottinghamshire County Council's website once received. This will include details of the criteria used to assess suitability for the post; how the candidate meets those criteria; and the terms and conditions on which the candidate is to be appointed.

Process

- 5. The confirmation hearing should be held in public, with the proposed appointee requested to attend to answer questions.
- 6. In line with guidance from the Local Government Association and Centre for Public Scrutiny, the focus of questioning from the Panel should be limited to issues of **professional competence** and **personal independence**. These are the standards that have been adopted in similar hearings held in the House of Commons.
- 7. This guidance also recommends that the Panel's decision-making should take place in closed session rather than in public.
- 8. Following the decision-making, the Panel must make a report, including a recommendation as to whether or not the appointment should be made. A recommendation that an appointment is not made is different to a veto and the

Police and Crime Commissioner could choose to ignore any such recommendation (with regard to appointments, the Panel only has power of veto over the appointment of a Chief Constable).

9. In response to the Panel's report, the Police and Crime Commissioner must then notify the Panel whether they will accept or reject the Panel's recommendation. There is no duty for the PCC to give reasons for their decision.

Other Options Considered

10. None – the Panel is required to hold a confirmation hearing for any senior appointment made by the Police and Crime Commissioner.

Reasons for Recommendation/s

11. To enable the appointment of the Deputy Police and Crime Commissioner to be considered by the Panel in line with the confirmation process.

RECOMMENDATION/S

That the Panel review the proposed appointment of Chris Cutland to the post of Deputy Police and Crime Commissioner and make a report to the Police and Crime Commissioner.

<u>Proposed Appointment of Deputy Police and Crime Commissioner</u>

I am proposing to appoint Chris Cutland as the Deputy Police and Crime Commissioner for Nottinghamshire.

Domestic Abuse and preventing violence against women and girls is one of my key priorities, along side ensuring that victims of crime are treated as people and not cases. An important part of my role is to give the public a strong voice in policing, criminal justice and community safety services. I have selected Chris as my Deputy to help me deliver on this priority and assist with delivering my wider responsibilities. I have worked with Chris for over 30 years and we have a strong relationship that will benefit the people of Nottinghamshire. Chris has a strong track record in partnership working and is a team player.

She will specifically have lead responsibilities for the following areas:

- Violence against women and girls
- Community Engagement and Volunteering
- Public Protection and Safeguarding

I have set out below Chris's professional experience for her new role:

- She has received public recognition for her work last year. She was one of a 100 women of substance in Nottingham City and runner up for the enterprise women of the year awarded by Derbyshire and Nottinghamshire Chamber of Commerce.
- Chief Executive of Women's Aid Integrated Services for over seven years. This involved the management of a large service and budgets.
- Previous working of working with senior elected officials, including MPs and other key decision makers



• Long history of partnership working with Nottinghamshire Police for over 20 years.

Chris will be appointed on a fixed term contract up to the next election of the Police and Crime Commissioner in May 2016. She will work equivalent to 3 days per week and be paid £60,000 (pro rata £36,000). This represents 80% of my salary (£75,000) and it is understood this is consistent with the salary of other Deputy Police and Crime Commissioner.

All other terms and conditions are the same as any other member of police staff employed by Nottinghamshire Police.

She intends to continue in her role as the Executive Director of Women's Aid Integrated Services in Nottinghamshire over the next few weeks to ensure a seamless handover. She will leave this employment on 31st December 2012 and focus solely on her responsibilities as the Deputy Police and Crime Commissioner from the new year.
