Adoption – tracing birth parents and immediate relatives

The Adoption of Children Act of 1926 came into effect in 1927. Prior to that date a child could only be fostered or placed with a guardian. Informal fostering was very common. There was not usually any record of these private arrangements. Occasionally references to boarded out children can be found in the Board of Guardians Poor Law records (SO/PUB-PUN).

From 1927 all adoptions made by courts in England and Wales are entered in the Adopted Children Register. The register is held by the General Register Office and indexes to them are available at the Family Records Centre. The registers are not open to the public but you can apply for information from them. The index is arranged by the surname of the adopting parents and date of adoption. It does not give the birth name of the child prior to adoption.

Until the 1970s adoptions could be arranged by an adoption society or agency, local authorities or privately by a doctor, solicitor, and priest or by the mother. New adoption regulations were implemented in 1984 and it became illegal for individuals to act in this capacity.

In England, Wales and Northern Ireland an adopted person is legally entitled to apply for access to their birth records when they reach the age of 18. In Scotland the age is 16.

The Adoption and Children Act 2002 came into effect in England and Wales on 30th December 2005. Adopted adults and their adult birth relatives now have the right to apply to an intermediary service for help in tracing

relatives. In Scotland, although there is no equivalent legal right, birth relatives can ask for similar help.

Intermediary services can be provided by a local authority, voluntary adoption agency or registered adoption support agency. A list of intermediary service providers can be found at www.adoptionsearchreunion.org.uk

How to Find Out More About Your Birth Family

1. Contact the adoption agency that arranged your adoption

This may be the local authority or a voluntary adoption agency. The agency may be able to provide some information from your adoption records and can provide the information you need to get a copy of your original birth certificate.

2. Obtain Your Birth Certificate

Since 1975, adopted people have had the right to apply for a copy of their original birth certificate. Certificates can be obtained from the General Register Office.

If you were adopted before 12 November 1975 you will have to attend a meeting with an adoption counsellor before you can be given your birth certificate. If you were adopted after 12 November 1975 you do not have to see a counsellor but this will be offered to you and it is strongly recommended that you seek advice and support.

On your original birth certificate you should find out –

- When and where you were born
- The name you were given at birth
- Your mother's name
- Your father's name (if given)
