Animal Movements at Showgrounds

Sheep, Goats and Pigs

It is important to have the necessary documents for reporting movements of animals both onto and away from a showground for use on showday.

Biosecurity rules must be strictly enforced at all times.

Reporting movements ON TO A SHOWGROUND

The Show Secretary or other authorised person must report all movements of Sheep, Goats and Pigs onto a showground to the Local Authority

These animals must arrive with the appropriate paperwork - a movement document

AML1 in the case of Sheep and Goats; or an

AML2 in the case of Pigs

- The Exhibitor must pass the PINK and WHITE copies to the authorised representative of the Show
- Sections A and B should have been completed in full by the exhibitor, and ***all animals individually identified***. Examples of individual identification given below:

Sheep/Goats UK123456-01 or S123456-01

Generally: UK or S + 6-figure number + further individual number

Pigs A1234-01 or WG1234-01

One or two letters + 4-figure number + further individual number

- Section C should have the showground entered as the destination, and any remaining detail within sections C and D must be completed by the show secretary or his representative (including the signature)
- The PINK copy is to be kept by the show secretary for a period of 6 months
- **It is the responsibility of the show secretary or his representative to forward the WHITE copy, within 3 days, to the address shown on the reverse of this leaflet.**

Reporting movements AWAY FROM A SHOWGROUND

The show secretary will need to have supplies of the Form AML1 Movement Document for Sheep and Goats, and AML2 Movement Document for Pigs, since the show animals will need a document completing for the return movement home.

Reporting movements AWAY FROM A SHOWGROUND (continued)...

For supplies of the movement documents AML1 and AML2 contact the Trading Standards Service shown at the bottom of this leaflet.

Procedure for movement documents AML1 and AML2:-

The AML1 or AML2 form must be completed as far as possible by the show secretary or representative before the animals leave a showground

Section A: the *departure CPH* is that of the showground
the *keeper* will be the show secretary (i.e. the temporary keeper/
contact for the Departure site)
the premises of departure, the show title and location
the official individual identification of the animals must be supplied
the show secretary or representative must sign at Section A in
confirmation of the details entered.

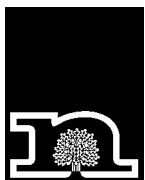
Section C: The show secretary must ensure that the destination address is completed whilst all the copies of the document are still attached.

The YELLOW copy is to be kept by the show secretary for a period of 6 months.

The PINK, BLUE and WHITE copies are to be passed to the person transporting the animals (there is no requirement for the show secretary to notify the Local Authority of a movement away from a showground).

Sections B, C & D: It is the responsibility of the exhibitor to notify of the return movement by completing the remaining detail in Sections B, C & D and forwarding the WHITE copy to their own Local Authority within 3 days of the movement.

This leaflet is a brief summary of the law regarding movement of sheep, goats and pigs onto and away from a showground. It is not an authoritative document on the law and is only intended for guidance. For further details or clarification contact the Trading Standards Service.
