A Monthly Analysis of Employment, Unemployment and Jobs

October 2014

Unemployment according to the Government's preferred measure was 1.96 million in the three months to September 2014, down 115,000 from the previous three months and down 529,000 from the same period a year ago. The unemployment rate was 6.0%, down 0.3 from the previous three months and down 1.6 from a year earlier.

The unemployment rate for 16-24 year olds was 16.2% in the three months to September 2014, down 0.7 on the guarter and down 4.9 on the year. There were 737,000 unemployed young people aged from 16 to 24 in the quarter July September 2014. to Comparisons of youth unemployment over time are complicated by the fact that unemployment rates are calculated as the number of unemployed people divided by the economically active population which excludes those not seeking or available for work.


The proportion of people aged from 16 to 24 in full-time education has increased substantially from 26.2% for March to May 1992 to 44.1% for July to September 2014. Increasing numbers of young people going into full-time education reduces the size of the

economically active population and therefore increases the unemployment rate. The lowest youth unemployment rate was 11.6% for spring 2001 and the highest rate was 22.5% for winter 2011.

The seasonally adjusted claimant figure for the United Kingdom decreased by 20,400 last month to 931,700 and was down 373,100 over the year.

The number of people in employment aged 16 and over increased by 112,000 over the guarter to reach 30.79 million. The employment rate for those aged 16 to 64 is now 73.0%, up 0.2 from the previous quarter and up 1.4 from a year earlier.

The number of people in full-time employment increased by 110,000 on the guarter to

The number of people in part-time employment was 8.27 million in the three months to September 2014, up 2,000 on the previous quarter.


In the three months to September 2014, there were 9.03 million economically inactive people aged from 16 to 64, up 38,000 from the previous quarter but down 16,000 from a year earlier.

Average total pay (including bonuses) was £481 per week in September 2014. Over the year total pay for employees in Great Britain increased by 1.0%. A v e r a g e regular pay (excluding bonuses) was £455 per week in September 2014. Over the year regular pay for employees in Great Britain rose by 1.3%. Between September 2013 and September 2014, the Consumer Prices Index increased by 1.2%.

There were 687,000 job vacancies in the three months to October 2014, up 22,000 from the three months to July 2014 and up 136,000 on a year earlier.

There were 2.9 unemployed people per vacancy in the period from July to September 2014, down 0.3 on the quarter and down by 1.7 on the year.

In the three months to September 2014, 91,000 people became redundant in the three



months prior to their Labour Force Survey interview. This is down 21,000 from the previous three months and down 34,000 on the year. The redundancy rate was 3.5 per 1,000 employees, down 0.8 from the previous three months and down 1.4 from a year earlier.

The unadjusted claimant figure for the United Kingdom has decreased by 35,469 over the month to 887,771. The proportion unemployed calculated on the residence base now stands at 2.2% of the population aged 16-64.

The number of claimants in Nottinghamshire decreased by 692 between September and October 2014. The total of 18,650 is 6,379 less than it was a year ago (see figure 1).

The proportion unemployed in Nottinghamshire is now 2.6%. This is higher than the East Midlands (2.0%) and the United Kingdom (2.2%).

Between September and October 2014, unemployment decreased in all of the four Travel To Work Areas in the County (figure 2). Mansfield experienced the largest decrease, with a rate of change of -4.8%, followed by Worksop & Retford with -3.5%, Nottingham -2.8% and Lincoln with -1.5%.

Compared with October 2013, all of the four TTWA's in the County have reduced numbers of claimants. The largest change has been in Worksop & Retford with a rate of change of -28.1% followed by Lincoln with -27.1% Mansfield with -25.4% and Nottingham with -25.3%.

Unemployment decreased in all of the seven Local Authority Districts in the County between September and October 2014. The largest decreases were in Newark & Sherwood with -8.0%

The rates shown in tables 1-4 are supplied by ONS. They are calculated by expressing the claimant count figures as a proportion of the resident population aged 16-64 derived from the latest mid-year population figures.

and Broxtowe with -7.3%. Unemployment in the City of Nottingham decreased by 217 over the month resulting in a rate of change of -2.3%.

The rates of change have varied throughout the County over the year, from -36.1% in Broxtowe to -23.4% in Ashfield. Nottingham City changed by -22.9% over the year.

Unemployment decreased in all of the eight Parliamentary Constituencies in the County during October. Broxtowe and Sherwood recorded the largest decreases, experiencing rates of change of -7.2% and -6.9% respectively, followed by Mansfield with -5.2% and Newark with -4.9%. Over the month Nottingham East has changed by -1.8%, Nottingham North by -2.0% and Nottingham South by -3.6%.

All of the eight Parliamentary Constituencies in the County have decreased numbers of claimants compared with the same period last year resulting in rates of change ranging from -23.8% in Mansfield to -35.7% in Broxtowe. The three Nottingham Constituencies have rates of change of -19.8% in Nottingham East, -24.7% in Nottingham North and -25.2% in Nottingham South.


