# A Monthly Analysis of Employment, Unemployment and Jobs

EB 9/15

# August 2015

Unemployment according to the Government's preferred measure was 1.82 million in the three months to July 2015, up 10,000 from the previous three months but down 198,000 from the same period a year ago. The unemployment rate was 5.5%, unchanged from the previous three months but down 0.7 from a year earlier.

The unemployment rate for 18-24 year olds was 14.1% in the three months to July 2015, down by 0.2% on the quarter and down 0.4% on the year. There were 578,000 unemployed young people aged from 18 to 24 in the guarter to July 2015. This is down by 7,000 on the quarter and down by 14,000 over the year. Comparisons of youth unemployment over time are complicated by the fact that unemployment rates are calculated as the number of unemployed people divided by the economically active


population which excludes those not seeking or available for work. Unemployment rates are not the proportion of the total population who are unemployed. They are the proportion of the economically active population (those in work plus those seeking and available to work) who are

unemployed. The long-term increase in the proportion of young people going into full-time education reduces the size of the economically active population and therefore increases the unemployment

The seasonally adjusted claimant figure for the United Kingdom decreased by 16,200 last month to 713,600 and was down 253,300 over the year.

The number of people in employment aged 16 and over increased by 42,000 over the quarter to reach 31.09 million. The employment rate for those aged 16 to 64 is now 73.5%, little changed from the previous quarter but up 0.7 from a year earlier.

The number of people in



full-time employment decreased by 6,000 on the quarter to reach 22.74 million. The number of people in part-time employment was 8.36 million in the three months to July 2015, up 49,000 on the previous quarter.

In the three months to July 2015, there were 8.99 million economically inactive people aged from 16 to 64, down 24,000 from the previous quarter and down 65,000 from a year earlier.


Average total pay (including bonuses) was £496 per week in July 2015. Over the year total pay for employees in Great Britain increased by 2.9%.

Average regular pay (excluding bonuses) was £465 per week in July 2015. Over the year regular pay for employees in Great Britain rose by 2.9%. Between July 2014 and July 2015, the Consumer Prices Index increased by 0.1%.

There were 740,000 job vacancies in the three months to August 2015, 6,000 more than in the previous three months and 58,000 more than a year earlier.

There were 2.5 unemployed people per vacancy in the period from May to July 2015, unchanged on the quarter but down by 0.6 on the year.

In the three months to July 2015, 107,000 people became redundant in the three months prior to their Labour



Force Survey interview. This is down 3,000 from the previous three months but up 15,000 on the year. The redundancy rate was 4.0 per 1,000 employees, down 0.1 from the previous three months but up 0.5 from a year earlier.

The unadjusted claimant figure for the United Kingdom has decreased by 15,367 over the month to 708,613. The proportion unemployed calculated on the residence base now stands at 1.7% of the population aged 16-64.

The number of claimants in Nottinghamshire increased by 88 between July and August 2015. The total of 15,758 is 4,317 less than it was a year ago (see figure 1).

The proportion unemployed in Nottinghamshire is now 2.2%. This is higher than the East Midlands (1.6%) and the United Kingdom (1.7%).

Between July and August 2015, unemployment decreased in two of the four Travel To Work Areas in the County (figure 2). Worksop & Retford experienced the largest decrease with a rate of change of -3.9%, followed by Lincoln with -0.3%. Mansfield and Nottingham had increases of 1.9% and 0.2% respectively.

Compared with August 2014, all of the four TTWA's in the County have reduced numbers of claimants. The largest change has been in Worksop & Retford with a rate of change of -29.8% followed by Mansfield with -22.0%, Nottingham with -20.7% and Lincoln with -15.7%.

Unemployment increased in five of the seven Local Authority Districts in the County over the month. The largest increases were in Rushcliffe with 6.3%, Gedling with 4.6% and Newark & Sherwood with 3.7%.

The rates shown in tables 1-4 are supplied by ONS. They are calculated by expressing the claimant count figures as a proportion of the resident population aged 16-64 derived from the latest mid-year population figures.

Bassetlaw and Ashfield decreased by -4.3% and -0.4% respectively. Unemployment in the City of Nottingham decreased by 45 over the month resulting in a rate of change of -0.6%.

The rates of change have varied throughout the County over the year, from -31.6% in Bassetlaw to -12.8% in Newark & Sherwood. Nottingham City changed by -20.6% over the year.

Unemployment

increased in five of the eight Parliamentary Constituencies in the County during August. Rushcliffe, Gedling and Sherwood recorded the largest increases, experiencing rates of change of 6.7%, 5.4% and 5.1% respectively. Over the month Nottingham East has changed by -2.4%, Nottingham North by 1.2% and Nottingham South by -0.2%.

All of the eight Parliamentary Constituencies in the County have decreased numbers of claimants compared with the same period last year resulting in rates of change ranging from -11.9% in Newark to -32.0% in Bassetlaw. The three Nottingham Constituencies have rates of change of -22.3% in Nottingham East, -18.4% in Nottingham North and -21.1% in Nottingham South.


