October 2015

Unemployment according to the Government's preferred measure was 1.75 million in the three months to September 2015, down 103,000 from the previous three months and down 210,000 from the same period a year ago. The unemployment rate was 5.3%, down 0.3% from the previous three months and down 0.7% from a year earlier.

The unemployment rate for 18-24 year olds was 12.7% in the three months to September 2015, down by 1.7% on the guarter and down 1.6% on the There were 518,000 unemployed young people aged from 18 to 24 in the guarter to September 2015. This is down by 72,000 on the quarter and down by 61,000 over the year. Comparisons of youth unemployment over time are complicated by the fact that unemployment rates are calculated as the number of unemployed people divided by the economically active


population which excludes those not seeking or available for work. Unemployment rates are not the proportion of the total population who are unemployed. They are the proportion of the economically active population (those in work plus those seeking and available to work) who are

unemployed. The long-term increase in the proportion of young people going into full-time education reduces the size of the economically active population and therefore increases the unemployment rate.

The seasonally adjusted claimant figure for the United Kingdom decreased by 11,200 last month to 695,400 and was down 226,300 over the year.

The number of people in employment aged 16 and over increased by 177,000 over the quarter to reach 31.21 million. The employment rate for those aged 16 to 64 is now 73.7%, the highest since comparable records began in 1971.

The number of people in full-time employment increased



by 31,000 on the quarter to reach 22.79 million. The number of people in part-time employment was 8.41 million in the three months to September 2015, up 145,000 on the previous quarter.


In the three months to September 2015, there were 8.97 million economically inactive people aged from 16 to 64, down 22,000 from the previous quarter and down 62,000 from a year earlier.

Average total pay (including bonuses) was £492 per week in September 2015. Over the year total pay for employees in Great Britain increased by 3.0%. A verage regular pay (excluding bonuses) was £463 per week in September 2015. Over the year regular pay for employees in Great Britain rose by 2.5%. Between September 2014 and September 2015, there was no change in the Consumer Prices Index.

There were 736,000 job vacancies in the three months to September 2015, 5,000 more than in the previous three months and 54,000 more than a year earlier.

There were 2.4 unemployed people per vacancy in the period from July to September 2015, down 0.2 on the quarter but down by 0.5 on the year.

In the three months to



September 2015, 111,000 people became redundant in the three months prior to their Labour Force Survey interview. This is down 1,000 from the previous three months but up 20,000 on the year. The redundancy rate was 4.2 per 1,000 employees, unchanged from the previous three months but up 0.7 from a year earlier.

The unadjusted claimant figure for the United Kingdom has decreased by 21,326 over the month to 664,130. The proportion unemployed calculated on the residence base now stands at 1.6% of the population aged 16-64.

The number of claimants in Nottinghamshire decreased by 720 between September and October 2015. The total of 14,453 is 4,197 less than it was a year ago (see figure 1).

The proportion unemployed in Nottinghamshire

is now 2.0%. This is higher than the East Midlands (1.5%) and the United Kingdom (1.6%).

Between September and October 2015, unemployment decreased in all of the four Travel To Work Areas in the County (figure 2). Mansfield experienced the largest decrease with a rate of change of -6.0%, followed by Nottingham with -4.6%, Worksop & Retford with -2.2% and Lincoln with -1.2%. Compared with September 2014, all of the four TTWA's in the County have reduced numbers of claimants. The largest change has been in Worksop & Retford with a rate of change of -30.7% followed by Mansfield with -22.3%, Nottingham with -22.0% and Lincoln with -16.6%.

Unemployment decreased in six of the seven Local Authority Districts in the County over the month. The largest decreases were in Mansfield with -7.5%,

The rates shown in tables 1-4 are supplied by ONS. They are calculated by expressing the claimant count figures as a proportion of the resident population aged 16-64 derived from the latest mid-year population figures.

Ashfield with -5.8% and Rushcliffe with -5.1%. Broxtowe experienced a small increase over the month resulting in a rate of change of 0.6%. Unemployment in the City of Nottingham decreased by 374 over the month resulting in a rate of change of -5.0%.

The rates of change have varied throughout the County over the year, from -31.2% in Bassetlaw to -10.3% in Newark & Sherwood.

Nottingham City changed by -22.2% over the year.

Un employment decreased in seven of the eight Parliamentary Constituencies in the County during October. Mansfield, Rushcliffe and Ashfield recorded the largest decreases, experiencing rates of change of -7.5%, -6.4% and -5.4% respectively. Over the month Nottingham East has changed by -5.2%, Nottingham North by -5.2% and Nottingham South by -4.4%.

All of the eight Parliamentary Constituencies in the County have decreased numbers of claimants compared with the same period last year resulting in rates of change ranging from -10.9% in Newark to -32.1% in Bassetlaw. The three Nottingham Constituencies have rates of change of -24.9% in Nottingham East, -20.3% in Nottingham North and -20.4% in Nottingham South.


