The purpose of carrying out an Equality Impact Assessment is to assess the impact of a change to services or policy on people with protected characteristics and to demonstrate that the Council has considered the aims of the Equality Duty.

## Part A: Impact, consultation and proposed mitigation

1 What are the potential impacts of proposal? Has any initial consultation informed the identification of impacts?

The Youth Service is an open access service whose provision is available to all 10-19 year olds (or until their 25<sup>th</sup> birthday if they have a disability and are already engaged with service delivery).

The proposal is to not replace two of the remaining five mobile youth facilities and remove their staffing establishment when they reach the end of their original anticipated lifespan on 01 April 2018. Work will be undertaken to seek to transfer the two mobiles to potential partners in the third sector to ensure the continuation of the provision in some form, at no cost to the Council.

With minimum reduction to the quantity and quality of Early Help and Positive Activities available to young people we will still meet the statutory obligation of a sufficient offer of activities as set out in the Government's Statutory Guidance for Local Authorities on Services and Activities to Improve Young People's Well-being.

There are some faith based and uniformed organisations that offer activities to people in these areas, but this not a direct alternative to Open Access Youth Work, and therefore may not be suitable for the young people that are currently attending this provision.
