February 2016

Unemployment according to the Government's preferred measure was 1.68 million in the three months to January 2016, down 28,000 from the previous three months and down 171,000 from the same period a year ago. The unemployment rate was 5.1%, down 0.1% from the previous three months and down 0.6% from a year earlier.

The unemployment rate for 18-24 year olds was 12.1% in the three months to January 2016, down by 0.2% on the guarter and down 2.2% on the There were 497,000 unemployed young people aged from 18 to 24 in the guarter to January 2016. This is down by 6,000 on the quarter and down by 90,000 over the year. Comparisons of youth unemployment over time are complicated by the fact that unemployment rates are calculated as the number of unemployed people divided by the economically active


population which excludes those not seeking or available for work. Unemployment rates are not the proportion of the total population who are unemployed. They are the proportion of the economically active population (those in work plus those seeking and available to work) who are

unemployed. The long-term increase in the proportion of young people going into full-time education reduces the size of the economically active population and therefore increases the unemployment

The seasonally adjusted claimant figure for the United Kingdom decreased by 25,400 last month to 605,400 and was down 190,200 over the year.

The number of people in employment aged 16 and over increased by 116,000 over the quarter to reach 31.42 million. The employment rate for those aged 16 to 64 is now 74.1%, the highest since comparable records began in 1971.

The number of people in full-time employment increased



by 62,000 on the quarter to reach 22.94 million. The number of people in part-time employment was 8.47 million in the three months to January 2016, up 54,000 on the previous quarter.


In the three months to January 2016, there were 8.89 million economically inactive people aged from 16 to 64, down 40,000 from the previous quarter and down 136,000 from a year earlier.

Average total pay (including bonuses) was £497 per week in January 2016. Over the year total pay for employees in Great Britain increased by 2.1%. Average regular pay (excluding bonuses) was £467 per week in January 2016. Over the year regular pay for employees in Great Britain rose by 2.2%. Between January 2015 and January 2016, there was a 0.3% increase in the Consumer Prices Index.

There were 768,000 job vacancies in the three months to February 2016, 10,000 more than in the previous three months and 26,000 more than a year earlier.

There were 2.2 unemployed people per vacancy in the period from November 2015 to January 2016, down 0.1 on the quarter and down by 0.4 on the year.

In the three months to January 2016, 111,000 people



became redundant in the three months prior to their Labour Force Survey interview. This is up 6,000 from the previous three months but down 3,000 on the year. The redundancy rate was 4.2 per 1,000 employees, up 0.2% from the previous three months but down 0.2% from a year earlier.

The unadjusted JSA claimant figure for the United Kingdom has increased by 4,356 over the month to 660,976. The proportion unemployed calculated on the residence base now stands at 1.6% of the population aged 16-64.

The number of claimants in Nottinghamshire increased by 391 between January and February 2016. The total of 14,264 is 3,763 less than it was a year ago (see figure 1).

The proportion unemployed in Nottinghamshire

is now 2.0%. This is higher than the East Midlands (1.5%) and the United Kingdom (1.6%).

Between January and February 2016, unemployment increased in two of the four Travel To Work Areas in the County (figure 2). Nottingham experienced the largest increase with a rate of change of 3.4%, followed by Mansfield with 0.2%. Lincoln experienced a 3.1% decrease over the month and Worksop & Retford decreased by 1.5%.

Compared with February 2015, all of the four TTWA's in the County have reduced numbers of claimants. The largest change has been in Worksop & Retford with a rate of change of -35.6% followed by Mansfield with -28.6%, Lincoln with -20.6% and Nottingham with -17.4%.

Unemployment increased in four of the seven Local Authority Districts in the County

over the month. The largest increases were in Gedling with 5.9%, Ashfield with 5.1% and Newark & Sherwood with 2.3%. Mansfield, Bassetlaw and Broxtowe have experienced decreases over the month resulting in rates of change of -3.7%, -1.6% and -1.0% respectively. Unemployment in the City of Nottingham increased by 315 over the month resulting in a rate of change of 4.4%.

The rates of change have varied throughout the

County over the year, from -36.8% in Bassetlaw to -15.5% in Gedling. Nottingham City changed by -15.8% over the year.

Un employment increased in five of the eight Parliamentary Constituencies in the County during February. Sherwood and Gedling recorded the largest increases, experiencing rates of change of 6.5% and 4.3% respectively. Over the month Nottingham East has changed by 4.2%, Nottingham North by 5.7% and

Nottingham South by 2.9%.

All of the eight Parliamentary Constituencies in the County have decreased numbers of claimants compared with the same period last year resulting in rates of change ranging from -15.6% in Rushcliffe to -38.2% in Bassetlaw. The three Nottingham Constituencies have rates of change of -16.2% in Nottingham East, -16.0% in Nottingham North and -14.8% in Nottingham South.


