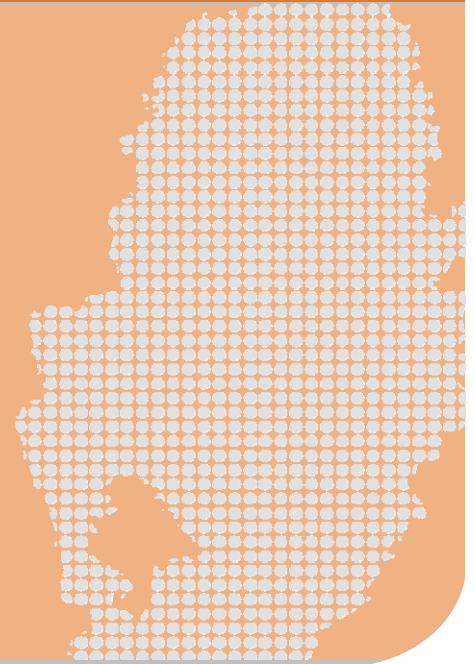


The child population in this area

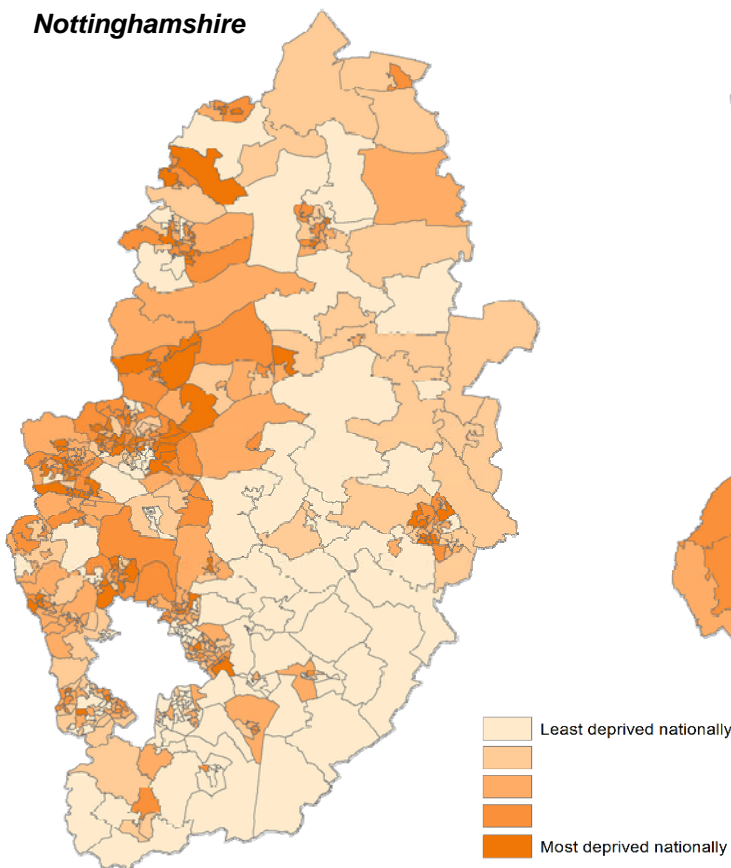
- 1,425 live births in 2015

Children living in poverty *

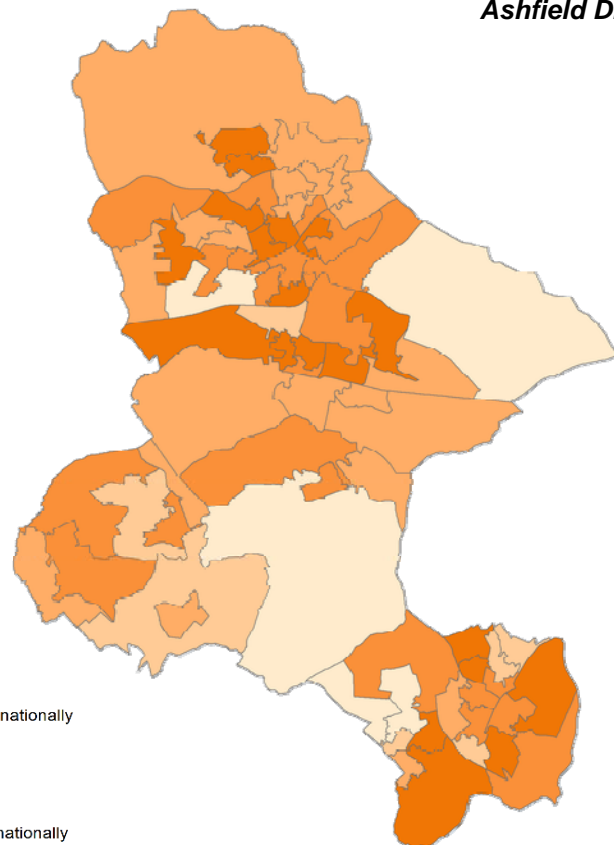

This map shows the differences in the levels of child poverty in Nottinghamshire.

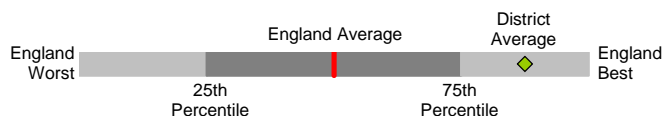
Ashfield District

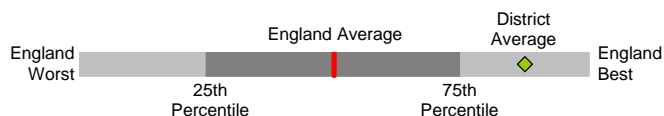
