16.09.16	Child Sexual Exploitation and Children Missing from Home and Care: Annual report 2015-16		
	TJ highlighted the key findings from the Child Sexual Exploitation (CSE) and Children Missing from Home and Care Annual Report 2015-16. It was recognised that whilst this area of work presents ongoing challenges, multi-agency work in Nottinghamshire is good and the response to issues is robust as supported by the findings of the recent Ofsted inspection.

16.09.16	Youth Homelessness Prevention Plan 2016-2020		
	LJ explained the background and context to the Youth Homelessness Prevention Plan 2016-2020 There was discussion about the profile of the children and young people involved, the quality of interagency working and the impact that planned changes in the benefits system is likely to have.		
	The Youth Homelessness Prevention Plan 2016-2020, as presented to the Executive, sets out the Authority's response to its statutory responsibilities. The Plan is owned by the Children's Trust and it was agreed that the Children's Trust Executive would recommend the Plan for approval by the Children's Trust Board at its November meeting. It was also agreed that it was appropriate for the Plan to go to the Children and Young People's Committee for noting.	LJ/CJ	Added to The Children's Trust Board Forward Plan
16.09.16	Dental Public Health in Nottinghamshire		
	GH shared information about the dental health of children and young people in Nottinghamshire and the three intervention strands of water fluoridation, dental service provision and oral health promotion activity.  There was lengthy discussion regarding water fluoridation. The decision to fluoridate now rests with Nottinghamshire County Council, having been passed over from the Primary Care Trusts at the point		
	of transfer of Public Health responsibility to local authorities. At present parts of Ashfield, Bassetlaw and Mansfield receive fluoridated water but not the other areas of Nottinghamshire. The health benefits of fluoridation are proven and the view of the meeting was that all children and young people in Nottinghamshire should receive the same health benefit and efforts should be made to ensure fluoridated water is available across the county. The challenge this poses was acknowledged due to the complexity of the water supply system and objections to fluoridation held by some members of the public. It was agreed that the report on Dental Public Health in Nottinghamshire should be presented to the Children's Trust Board meeting at its November meeting with the recommendation from the Executive that action should be taken to pursue water fluoridation across Nottinghamshire. 16.09.16	Implementation of Schools Health Hub		
	KA updated colleagues on the development of the Schools Health Hub including plans to integrate the hub within the newly formed 'Threats to Children Team' and the planned work to quality assure and help schools identify health and wellbeing interventions offered to them. 	Schools Health Hub Co-ordinator posts were shared along with information about the proposed areas of support to schools. It was recognised that the funding for the Schools Health Hub is non-recurrent and is therefore time limited. The mechanisms for links with the Clinical Commissioning Groups was outlined. Methods for evaluation of the impact of the Schools Health Hub have not yet been determined but it was agreed that the Children's Trust Executive will be kept updated with progress. 	IK explained that this report was a follow on to the report made to the Children's Trust Executive in July 2016. It was recognised that there is no new funding available from within the Local Authority and the preferred option is a reduction in the number of Locality Management Groups and the frequency of their meetings along with a reduction of the number of Locality Partnership Managers to one or 0.8 fte funded by contributions from all Children's Trust partner agencies.		
	After some discussion it was concluded that none of the partner agencies would be in a position to offer funding. Previously there had been an acknowledgment of the important contribution of Locality Management Groups but the difficulty of evidencing their impact or to quantify the cost of them no longer existing.		
	It was recommended that each Locality Management Group should consider its own future and the possibility of moving towards becoming a self sustaining network either individually or collectively and that this recommendation be shared with the Children's Trust Board meeting in November 2016. 	A copy of the letter from Ofsted and the Care Quality Commission giving the findings of the inspection carried out in June 2016 was circulated to colleagues. DHi noted the close correlation between the inspection findings and the Authority's self-assessment; broadly speaking the findings are extremely positive.
