

The Nottinghamshire County Council (Bassetlaw Area – various byways)(Prohibition of Driving) Traffic Regulation Order (1191)

NOTICE IS HEREBY GIVEN that the Nottinghamshire County Council HAS MADE an Order under the Road Traffic Regulation Act 1984, as amended, the effects of which will be to roads and byways in Bassetlaw Area of Nottinghamshire:-

1. The following list of **byways** are to be **closed** to all motorised traffic (except solo motor cycles) and horse drawn vehicles between **1st November** and **30th April**.
 - (i) Beckingham Byway No 16 (West Road) and Walkeringham Byway No 14 (Oaks Lane) (Beckingham and Walkeringham).
 - (ii) Clarborough Byway No 22 (Market Hill) (Clarborough)
 - (iii) Hayton Byway No 4 (Hollinhill Lane) and Hayton Byway No 7 (Hangingside Lane)(Hayton)
 - (iv) Marnham Byway No 8 (Crabtree Lane) (Marnham and Fledborough)
 - (v) Misterton Byway No 18 (Debdhill Road)(Misterton)
 - (vi) Misterton Byway No 24 and Walkeringham Byway No 11 (Tupcroft Road)(Misterton and Walkeringham)
 - (vii) North Leverton Byway No's 11, 14 & 15 & Cottam Byway No 5 (North Leverton with Habbleshthorpe and Cottam)
 - (viii) South Leverton Byway No 14 (Brickings Lane) and South Leverton Byway No 15 (Meadow Dike Lane)(South Leverton)

The closure has been introduced during the winter months when the weather makes the surface of the byway wet and muddy. The restriction will prevent the use of the byway by motorised vehicles (except solo motor cycles) and horse drawn vehicles. Closing the byway during the winter months will reduce the damage to the surface of the byway making it safer for all other users. The byways have been identified as being damaged by the overuse of motorised vehicles.
