- 1. On average, between the period of the 30th September 2016 1st October 2017,
 - a. What was your headcount of employees? At Nottinghamshire County Council there were 7529.3 employees (FTE 5472.3) Including maintained schools there were 16050.3 employees in total (FTE 11465.5)
 - b. What was your headcount of apprentices?
 For the period Sept 2016 5th April 2017, apprentices were not employed directly by Nottinghamshire County Council . we partnered with an Apprentice Training Agency.
 Since the introduction of the Apprenticeship Levy there are 75 apprentices employed by Nottinghamshire County Council, including schools.
 - c. What was your headcount of apprentices, that had a disability? From the declared information there are 10 apprentices that have declared a disability.
- 2. In the period between 30th September 2016 1st October 2017,
 - a. How many apprenticeship starts were made during this period? From levy implementation, there were 39 apprentice starts.
 - b. How many apprenticeship starts were made during this period by people that had a disability?
 From the information that we have access to, there were 10 formal offers for the period 1st April 2017 1st October 2017
 - c. How many people applied for your apprenticeships, that had a disability? From the 1st April 2017 there were 19 applications submitted that declared they had a disability.
 - d. How many people received interviews for your apprenticeships, that had a disability?
 10 applicants received on interview.
 - 19 applicants received an interview.
 - e. How many people were unsuccessful in securing your apprenticeships, that had a disability?
 - There were 9 unsuccessful applicants from the 1^{st} April 2017 1^{st} October 2017.
