Please can you provide the name of the electricity and/or gas provider used by the council for each building for each of the years [2012](#), [2013](#), [2014](#), [2015](#), [2016](#), [2017](#), [2018](#) (projected). Some may have different providers for electricity and gas.

Please can you provide the total usage of electricity and gas (in kWh) by the council for each building for each of the financial years.

Please can you provide the total amount of money spent by the council on gas and electricity for each building for each of the financial years.

Please can you provide the energy plan type for electricity and gas from the energy provider that the council signed up to for each building for each of the financial years.

Please can you provide any details of plans to switch energy provider or save costs on energy bills for these council buildings in the coming three years.

I understand that this data is routinely collected and also provided by the council's electricity/gas supplier.

You will be aware that there are 20 working days in which to reply to this application.

If you anticipate that this request will exceed the cost limit, please provide the data for the most recent years, working backwards in time until the cost limit is reached.
