

## Locality Roles:

- **Early Years Project Officers** implement a range of projects as part of a wider programme to support Early Years initiatives and fulfil statutory duties. They lead on the assessment and establishment of schools and Private, Voluntary and Independent (PVI) early provision; supporting Nottinghamshire County Council to fulfil its statutory duties for early years provision and childcare sufficiency.
- **Early Years Teachers** provide skilled educational support, advice and training to early years providers and those working within early childhood services to meet service standards within the Early Years Quality and Attainment team. Teachers promote high quality provision, to raise attainment for all children and to narrow the attainment gap.
- **Early Years Advisors** provide assistance to the Early Years Teachers to promote and support the delivery of high quality early education and childcare provision in order to raise attainment, especially for vulnerable children. They work with early years providers to support and challenge them to improve the quality of their provision in line with Ofsted expectations.

## Countywide Roles

- **Early Childhood Services Strategic Commissioning Manager** leads on Nottinghamshire County Council's approach to commissioning early childhood services, ensuring that services are responsive to meet local population need. They have a lead role in commissioning Children Centre services, Families Information Service, training and procurement of early years provision.
- **Early Years Strategic Manager** leads on national duties placed on the Local Authority for early years provision, childcare sufficiency and quality assurance; taking a leadership and line management role with Early Years Project Officers and the Early Years Advisory Service including operational, technical and professional staff to deliver required objectives.
- **Early Years Senior Practitioner** supervises front line staff to meet the required service standards within the Early Years Quality and Attainment Team and to provide educational support, information and guidance to early years providers.
- **Early Childhood Services Contracts and Performance Officer** commissions and performance manages Early Childhood Services on behalf of Nottinghamshire County Council including Children Centre services.
- **Early Years Business Sustainability Officer** supports schools and Private, Voluntary and Independent (PVI) early years providers with their financial and business planning on behalf of Nottinghamshire County Council.
- **Early Childhood Data Officers** ensures that the delivery of free early years provision is conducted in accordance with national policy guidance and that all relevant data is collated and recorded. Managing the funding streams, budget and payments associated with the provision of Early Years services, via the local authority and PVI sectors, and managing the Nursery Education Fund on behalf of the LA.
- **Early Childhood Services Group Manager** has overall responsibility for the service and statutory duties of the local authority.
