Thank you for your request for information relating to Voyage 1 Limited for the Unplanned Care Service on the 14/11/2017

I am afraid on this occasion that we are withholding this information under S43(2) of the Freedom of Information Act on the grounds that release would be likely to prejudice the commercial interests of another body (Voyage 1 Limited.

Before reaching this decision we considered whether the public interest in withholding this information outweighed the public interest in disclosure, and taken the responses from the organisation and legal advice in order to come to this decision.

For example

We accept that there is a generic public interest in public sector contracts and in how they are awarded. Releasing information about procurement increases public confidence in the spending of public money and demonstrates equity and fairness in the procurement process.

However, against this must be balanced the legitimate commercial interests of companies who do business with the Council. Releasing the specific costs you requested would significantly prejudice the commercial interests of those companies in any future tender process. It would provide a significant advantage to their direct competitors and would considerably affect their ability to operate effectively in the competitive marketplace.

Furthermore, there is no suggestion that the correct procurement processes were not followed on this occasion which might justify closer scrutiny of the contract.

It is our conclusion, therefore, that on balance the public interest lies in withholding this information.
