Request for Information: Ref NCC-029715-17 Road Maintenance

Thank you for your request for information relating to Road Maintenance. I can now let you have the following information in response to the guestions you raised.

(Please note that we do not undertake temporary repairs in Nottinghamshire. We aim to fix all identified repairs with a permanent repair and this includes potholes. Potholes are repaired using a proprietary repair material specially designed for use in such repairs. The number of pothole jobs undertaken by year and including this year to date is as follows. Please note a job may include multiple pothole repairs).

Please do not interpret this data as meaning that there has been a year on year increase in pothole repairs. With the move from treating pothole repairs from temporary to permanent 2-3 years ago and the change in repair technique resulted in many repairs that we previous patched being fixed on first time visit through a pothole repair hence the steady increase.
