Request for Information: Ref NCC-029719-17 Claims History

Thank you for your request for information relating to NCC claims history. I can now let you have the following information in response to the questions you raised.

As on 27 February 2018, the total value of third party claims (liabilities, motor) received in 2016/17 by Nottinghamshire County Council is £5,629,450.

As we do not hold the information centrally requested sections A,B, C and D we estimate it would take a minimum of 58 hours to collate. You may be aware that there is a statutory limit to the amount of time authorities are required to spend retrieving and collating information in order to respond to a request. This is defined in the Fees and Appropriate Limit Regulations and currently stands at 2.5 days. We estimate that it will take one officer in excess of 2.5 days to locate the information you have requested. Under Section 12 of the Freedom of Information Act we are not obliged to process requests that exceed this limit.
