Request for Information: Ref NCC-030186-17 Complaints about potholes

Thank you for your request for information relating to complaints about potholes. I can now let you have the following information in response to the questions you raised.

* How many reports and complaints about potholes have you received in each year since 2009/10?

The table below shows the total of enquiries raised, for each financial year under the subjects Carriageway Damage and Carriageway Pothole. Please note we do not separate enquiries for the different types of defects.

* How much was spent on resurfacing and fixing potholed roads in each year since 2009/10?

We can only provide information for the last 5 years based on accessible records. This information is split Capital Funding which is the planned maintenance programmes for each year (including carriageway, footway, drainage, surface dressing, bridges, traffic signal, safety fencing, and street lighting) and Reactive Maintenance that covers the day to day maintenance of the network. In recent years the Department for Transport has provided additional funding as

indicated in the separate years. This funding can not only be used to undertake small repairs but can also be utilised to fund resurfacing activities. Therefore, whilst this data is an accurate record of funding it may not provide the exact breakdown requested.

2017/18 Reactive Maintenance - £2.4m + £1.174m DfT Pothole Action Fund + recently announced additional £815k DfT Pothole Fund allocation = £4.389m. Capital Maintenance - £15.4m

2016/17 Reactive Maintenance - £2.4m + £0.839m DfT Pothole Action Fund = £3.239m. Capital Maintenance - £15.3m

2015/16 Reactive Maintenance - £2.4m. Capital Maintenance - £14.9m

2014/15 Reactive Maintenance - £2.4m + £2.781m DfT Pothole Fund = £5.181m. Capital Maintenance - £14.1m

2013/14 Reactive Maintenance - £2.4m + £1.565 DfT Weather Repair Fund = £3.965m. Capital Maintenance - £14.1m

* Approximately what proportion of the roads in your area needed maintenance work because of uneven surfaces or potholes in each year since 2009/10?

In order to provide an answer to this question we have referred to the Road Condition Indicators that many Authorities use to monitor the local network performance. The RCI is split A Roads, B & C Roads and Unclassified Roads with the following showing the percentage road network where maintenance should be considered.

Please note that these figures are compiled from technical surveys utilising defined reporting techniques. The data above has been complied using the term 'considered' considered will indicate all sites that have to be reviewed to determine a maintenance programme. Maintenance works do not directly correlate with the amount of repairs undertaken, for example a repair may be all that is required to restore the road surface at a specific location.
