Request for Information: Ref NCC-030934-18 Local Road Network in relation to the A611 Ashfield / Mansfield Corridor Junction Improvements Scheme

Thank you for your request for information relating to local road network in relation to the A611 Ashfield / Mansfield Corridor Junction Improvements Scheme. I can now let you have the following information in response to the questions you raised.

- a. Documents that accompanied the joint bid to the National Productivity Investment Fund for the Local Road Network in relation to the A611 Ashfield / Mansfield Corridor Junction Improvements Scheme bid, including: Map showing location of the project and its wider context; LEP support letter; Projects impact pro forma; Appraisal summary table; and Project plan/Gantt chart.
- b. Any and all replies received from the Department for Transport, including in particular any reasons given for refusal, and including the letter dated 31 October 2017 in full (with names redacted).
- c. Documents, including correspondence, pertaining to the commissioning of transport consultants Aecom in relation to looking afresh at the A608/A611 corridor between Mansfield and Junction 27 of the M1, including any briefs setting out the scope of the study, etc. including, for example, the range of possible highway and transport mitigation schemes for the study to consider.
- d. Correspondence and any other evidence that supports the Council's affirmative answer to National Productivity Investment Fund for the Local Road Network Question B12. Management Case Local MP support.
- e. Any assessment carried out by or on behalf of Nottinghamshire County Council in relation to the anticipated potential impacts of implementation of the proposed (but unsuccessful) A611 Ashfield / Mansfield Corridor Junction Improvements Scheme on the other junctions along this route (as listed in Table 4.1 of the June 2017 A611 Economic Impacts Transport Study), including any assessment made of the potential net overall increase or decrease in Cost of Delays (including those associated with the A611 / Forest Road junction), and any assessment made of the anticipated pollution impacts that might have arisen had the A611 Ashfield / Mansfield Corridor Junction Improvements Scheme gone ahead.
