## Background.

In 2010 Nottinghamshire County Council began a programme of modernisation for their internally run day services.

Following consultation, a programme of changes reconfiguring and restructuring the directly provided day services to offer an equitable service across the county to all service user groups and utilise premises more effectively began. Between 2011 and 2013 day services management and staffing were restructured to provide a more efficient service able to meet the needs of a range of service users. During this period, 13 buildings were developed into high quality multi-purpose day service bases across the county. This development allowed the release of 21 buildings.
