ROAD TRAFFIC REGULATION ACT 1984

**The Nottinghamshire County Council
(B6041 (Farmers Branch and Kilton Hill, Worksop) and B6045 (Blyth
Road, Worksop)) (Speed Limit) Order 2014 (1163)**

The NOTTINGHAMSHIRE COUNTY COUNCIL ("the Council") in exercise of its powers under Sections 82(2), 83(2), 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. The length of roads specified in Schedule 1 to this Order shall be a restricted road for the purposes of Section 81 of the Act of 1984.
2. No person shall drive any vehicle at a speed exceeding 30 miles per hour on the length of road specified in Schedule 2 to this Order.
3. The Orders in Schedule 3 shall be revoked in so far as they related to the lengths of road in Schedules 1 and 2.
4. This Order may be cited as "The Nottinghamshire County Council (B6041 (Farmers Branch and Kilton Hill, Worksop) and B6045 (Blyth Road, Worksop)) (Speed Limit) Order 2013 (1163)" and shall come into force on the 28th day of April 2014.

SCHEDULE 1

Length of roads in Worksop in the District of Bassetlaw:

B6041 Farmers Branch, extending from its junction with the B6045 Blyth Road in a westerly direction, for a distance of 487 metres.

B6041 Kilton Hill, extending from its junction with the B6045 Blyth Road, in a southerly direction, for a distance of 480 metres (525 yards).

B6045 Blyth Road, extending from a point 105 metres north-east of its junction with the B6041 (Farmers Branch) in a south-westerly direction to a point 194 metres north-east of its junction with Inglemere Close (an approximately distance of 554 metres).

B6045 Blyth Road, extending from its junction with Thievesdale Lane in a south-westerly direction to a point 11 metres south-west of its junction with Thievesdale Lane (an approximately distance of 53 metres).

SCHEDULE 2

Length of roads in Worksop in the District of Bassetlaw:

B6045 Blyth Road, extending from a point 11 metres south-west of its junction with the Thievesdale Lane in a south-westerly direction to a point 105 metres north-east of its junction with the B6041 (Farmers Branch) (an approximately distance of 441 metres).

B6045 Blyth Road, extending from its junction with Thievesdale Lane in a north-easterly direction for a distance of 19 metres.


SCHEDULE 3

The following orders shall be revoked in so far as they relate to lengths of road specified in Schedules 1 and 2:

- The Nottinghamshire County Council (Thievesdale Lane and Old Thievesdale Lane, Worksop) Speed Limits Order 1988 Schedule 2.
- The Borough of Worksop Blyth Road (B6045) and Kilton Hill (B6041) (40 M.P.H. Speed Limit) Order 1973.
- Any previous Order relating to speed limits.
