**Implementation date and any proposed stages for implementation:**

2. The date on which the proposal is planned to be implemented, and if to be implemented in stages, a description of what is planned for each stage, and the number of stages intended and the dates of each stage.

**1 September 2019.**

**It is proposed to increase the capacity at East Markham Primary School (“the School”) by increasing the number of pupils to be accommodated from 144 to 210 in Years Reception to Year 6 (ages 4 to 11).**

**It is proposed that the expansion would be implemented with the School taking up to 30 pupils in all year groups from 1 September 2019. If the proposal to increase the capacity of the School is implemented, the Published Admission Number for entry to the Reception year group will be 30 pupils from September 2020. There would be an in-year variation for September 2019 in order to allow up to 30 pupils to be admitted in 2019/20. If 30 pupils were to be admitted to all year groups, then the School would be at its maximum capacity of 210.**

**It is anticipated that the necessary building work will be completed by September 2019.**

**To increase the school's net capacity by expanding the school's existing premises.**

**NCC proposes to make a prescribed alteration to East Markham Primary School by expanding the school's current net capacity from 144 permanent places to 210 from September 2019.**

**Objectives:**

7. The objectives of the proposal.

**East Markham has experienced significant growth in the past 10 years and is expected to continue to grow in the future. There is a demand for places at the school and it is a Good school according to its latest Ofsted inspection report, conducted in February 2018. Expanding the school would increase the provision of places at good schools in the area and increase the choices available to parents. For those families moving into new homes in the area, there would be more local availability, increasing the ability for children to walk to school and reducing the need to attend schools some distance away from their community. This would contribute to improved attendance, family wellbeing and local cohesion.**

## Evidence of Demand:

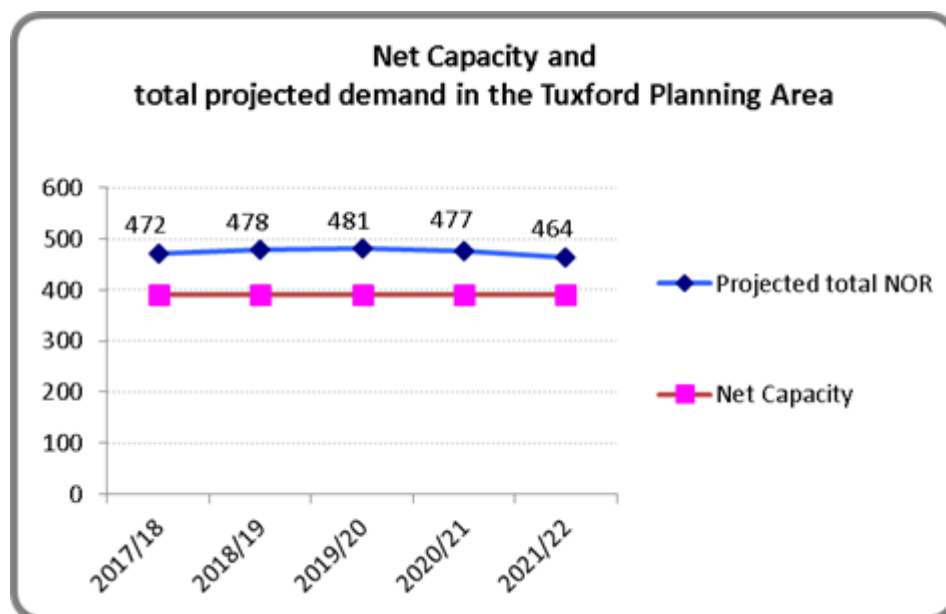
### 8. Evidence of demand for the additional school places.

In line with the underlying national trend, Nottinghamshire has seen an increase in the overall school population, particularly in the numbers of primary age children.

The total primary Number on Roll (NOR) has seen an increase over the past few years which causes difficulties for parents moving into an area where there are no places at their local (catchment area) school.

The area served by East Markham Primary School lies within the Tuxford Primary Planning Area, comprising of East Markham, Dunham C of E and Tuxford primary schools. This area has a growing population due in part to an increase in house building. The number of children of primary school age in this area is forecast to continue to rise over the next few years as can be seen in the chart below:

The graph below represents the projections and net capacity for the Tuxford Primary planning area for the period 2017/18 – 2021/22



Due to the increase in numbers already attending the school, it has been necessary to change the use of some of the rooms in the school which has resulted in the school now having no hall and having a kitchen that cannot adequately provide meals for the number of children attending the school. In order to address these matters, and to provide suitable accommodation for the children in the area both now and in the future, it is necessary to expand the school's accommodation in line with it being a school able to admit up to 30 children per year. Without this increase in provision, the ability of the school to continue to provide a good standard of education will be limited. The curriculum needs of a primary school of this size requires an appropriately sized school hall which will serve both the school and the local community. As numbers rise, the school kitchen, which already is undersized, should be able to provide for the needs of a larger school and so needs to be replaced.
