HIGH NEEDS BLOCK FORECAST OUTTURN 2018/19

Purpose of the Report

1. To report the forecast outturn position of the High Needs Block for 2018/19.

Information and Advice

2. Due to the current and projected pressures on the High Needs Block it was agreed at the January 2018 Schools Forum meeting that regular budget monitoring reports would be presented to keep members informed of the financial position.

Summary Financial Position

- 3. Nottinghamshire County Council's (NCC) High Needs Block Allocation for 2018/19 is £62.240 million. Due to the projected budget pressure reported to Schools Forum in October 2017 it was agreed to transfer 0.5% of the Schools Block to the High Needs Block giving a total High Needs allocation of £64.595 million.
- 4. The High Needs Block is forecast to overspend by £2.444m, as summarised in Table 1 below.

Forecast Variances

Forecast variances are detailed below.

Special School Funding is underspending by £0.065 million as some proposed new special school places are still to be commissioned

The overspend on Independent Non Maintained (INM) special school placements for children with EHCP of £1.281 is due to continued growth in the number of children with EHCPs requiring a placement in INM. 99 new packages have been approved by the Education Specialist Provision Panel since April 2018.

The overspend on HLN of £1.211 million is due to continued growth. The number of HLN pupils supported has increased from 520 in 2016-17 to 602 in 2018-19.

Due to actions taken to mitigate overspends in the High Needs Block, no other services are currently forecasting anoverspend.
