We have received the following request from a customer:

He would like to know the following:

When was policy voted in prohibiting Vans with trailers attached from using the household waste and recycle centres?

He would also like information on the legislative notices, where were these published and when? On the back of when this decision was made.

Thank you for your recent Freedom of Information Request.

I am now able to provide you with the Information supplied by the relevant department, as follows:

The policy of not accepting vans with trailers at the RC's has been in operation since the 1990s and we no longer hold the background papers which made this decision.

The present registration scheme for all residents was introduced on 22 March 2016. The registration website page states that a "van with any trailer" cannot be used:
