We had 58 CCs to start with, and continue to have 58 CCs, since much of the service is delivered through outreach, rather than from specific buildings. Not all CCs have ever had a building, delivering on a community based outreach approach. We have had minimal changes since 2010, as in the main we have converted buildings to early year's education and childcare, rather than give them up altogether, however Carlton CC building was declared surplus, along with Rosebrook bungalow - part of Ladybrook CC, but main Ladybrook site remains, and a second building at Stapleford CC was also declared surplus.
