Introduction

Why do we use your data?

For service delivery

What legal reasons allow us to use your data in this way?

Our legal basis for processing your personal data is that it is necessary to perform our public tasks as a local authority.

What will happen if you do not provide or we cannot obtain the data needed?

We could not provide the service to you.

Who may we share your data with or receive it from?

- Between service delivery partners:

- Nottinghamshire County Council's integrated health & wellbeing delivery partners (where you have expressed an interest in a health & wellbeing related services)
- Cycling delivery organisations (where you have expressed an interest in receiving cycle related services)
- Bus and rail operating companies (where you have used tickets provided by us)
- Alphagraphics printing company (where you have requested a household paper travel survey)
- RCAN (where you have expressed an interest in applying for a moped loan)
- From the Jobcentre Plus (where you have accessed the service or incentives through a Jobcentre)
- From your employer (where you have completed a paper travel survey)
- Digital survey providers, information may be temporarily stored by Citizen Space, Smart Survey and/or SNAP during the data collection process (where you have completed a paper, online or telephone travel survey).

Does the service make decisions using fully automated processes?

Who will be using your data?

Nottinghamshire County Council will process your data and we may also contract third parties to process your data on our behalf

- To object to the use of your data
- To have your personal data erased
- To request that we transfer your information to you or another organisation
- To object to fully automated decision making
- To withdraw your consent (if it the legal reason why we use your data).
